For and on behalf of Orissa Power Transmission Corporation Limited, the Executive Engineer, Civil Works Division No.I, OPTCL, Bhulbaneswar invites percentage rate bids in single cover system for the works through e-procurement as detailed in the table. The bid should be submitted only online in the http://tenderorissa.gov.in by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The bioders should have the necessary Portal Enrolment (with his own digital signature certificate).

6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-III or Class-III.

7. Bids shall be received only "online" on or before 17.00 Hours of 8.10.2013

8. Bids received "on line" shall be opened at 11.30 Hours on 17.10.2013 in the office of the Executive Engineer(civil), Civil Works Division No.I, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, a the bids will be opened on the next working day.

9. The bidders shall furnish the attested copies of the valid registration certificate, PAN, Valid VAT clearance, Service Tax Registration Certificate and Labour License along with his Bid failing which his / her bid shall not

be considered.

The successful bidder shall have to deposit additional performance security when the bid amount is seriously unbalanced i.e. less than the estimated cost by more than 10 %, in such an event the successful bidder shall deposit the additional performance to the extent of the differential cost of the bid amount and 90 % of the estimated cost in shape of Post Office Saving Bank Account / NSC / KVP / Deposit receipt of scheduled Bank.

Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference for availing the facilities. Engineering contractors should submit an attested copy of Engineering degree certificate and an undertaking in shape an affidavit that he has not availed
