For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites percentage rate bids in **Double Cover system** for the works through e-procurement as detailed in the table. The bid should be submitted only online in the <http://tenderorissa.gov.in> by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).
2. The bidders may submit bid for the works as per the following table :-

3. Bid documents consisting of specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website <http://tenderorissa.gov.in> as specified at column-8 above except on Sundays and public holidays.
4. Bids must be accompanied by and Earnest Money Deposit / Bid Security of the amount @ of 1 % of the estimated cost specified for the work in shape of **Deposit Receipt of Schedule Bank /N.S.C. / K.V.P. / Post Office Savings Bank Account /Post Office Time Deposit Account** pledged in favour of **Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar** and will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire machineries or equipment's from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid Security.
5. The Bid documents will be available in the <http://tendersorissa.gov.in> from **11.00 Hours of 22.02.2016 to 08.03.2016 up to 17.00 Hours.**
6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
7. Bids shall be received only “online” on or before **17.00 Hours of 08.03.2016**
8. The Cover-I(Techno-Commercial Document) of the Bids received “on line” shall be opened at **11.30 Hours on 15.03.2016** in the office of the Superintending Engineer (civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day. The date of opening of Cover-II(BOQ) will be communicated in due course of time to the qualified bidders of Cover-I.
9. The bidders shall furnish the attested copies of the valid Contract Licence, Pan, VAT-612, Service Tax Registration Certificate(ST-2), valid labour licence, Solvency Certificate from a Nationalised /Scheduled Bank issued within last 6(Six) month , Copy of Balance Sheet and Turn Over for last Three Years(duly certified by a Chartered Accountant), list of works executed with in last three years, list of works in hand along with self-attested copies of supporting documents and Turn Over Certificates mentioning Civil Works for last Three Years(duly Certified by Chartered Accountant), Schedule-A to F & other documents as mentioned in DTCN.
10. The successful bidder shall have to deposit additional performance security when the bid amount is seriously unbalanced i.e. less than the estimated cost by more than 10% and within 15%, in such an event the successful bidder shall deposit the additional performance security to the extent of 1.5 times

- of the differential cost of the bid amount and 90% of the estimate cost in shape of Post Office Saving Bank Account / NSC / KVP / Deposit receipt of scheduled Bank. when the bid amount is up to 10% less than the estimated cost, no additional performance security is required to be deposited.
11. Exemption holder like SC/ST/ contractors should submit attested copy of caste certificates and an application for rate preference for availing the facilities. Engineering contractors should submit an attested copy of Engineering degree certificate and an undertaking in shape an affidavit that he has not availed concession 3 (three) time in the current financial year **2015-16** and the PH bidders Should produce their original registration certificate stating the fact of physically handicapped by their registration authority with the bid, failing which they will not get price preference as per rule.
 12. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.
 13. The packet super scribing the name of the work and containing cost of bid document & EMD/Bid Security in original and other documents may be submitted in the office of the undersigned after bid closing date **08.03.2016** and on or before 17.00 Hours on dated **14.03.2016** during office hours on working days failing which the bid will be rejected
 14. The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank mentioned at column-6 above, payable at Bhubaneswar **separately** towards cost of each tender.
 15. The bidders should have successfully completed at least a single **similar nature of work** worth tender value **of ₹ 70.00 Lakh or more** in any during the last three financial years i.e. **2012-13, 2013-14 & 2014-15** . The bidders failing to produce authenticated document in support of work experience from competent authority is liable for rejection. Experience certificate from any Private Organisation will not be entertained. Experience certificate furnished below the rank of Executive Engineer of Government Department/Public Sector Undertaking will not be accepted. The original agreement in support of experience certificate submitted by the bidder will be verified before opening of the financial bid. **(experience such as : Construction/renovation of building)**
 16. The bidder is required to furnish Solvency Certificate of ₹ 50.00 Lakh for work from a Nationalised /Scheduled Bank issued within last 6(Six) months.
 17. The bidders are to submit Balance Sheet and Turn Over Certificate of last 03(Three) financial years i.e. from 2012-13 to 2014-15 duly certified by Chartered Accountant.
