GENERAL TERMS AND CONDITIONS OF CONTRACT [G.T.C.C.]

1. Scope of the contract:

The scope of contract covers Renovation of retaining wall around the switchyard of grid substation Kendrapada with providing drainage system in 33 KV side of switch yard area and providing wire mess fencing around the switch yard under EHT (O&M) Division, Choudwar as per the technical specification and price schedule at Section-IV including supply of all materials, labour, T&P, transportation & mobilization to site to complete the work in all respect.

2.0 Definition of terms:

For the purpose of this specification and General Terms and Conditions of contract [GTCC], the following words shall have the meanings hereby indicated, except where otherwise described or defined.

- 2.1 "The Purchaser" shall mean the General Manager, EHT (O&M) Circle, Cuttack for and on behalf of ODISHA POWER TRANSMISSION CORPORATION LTD.,

 Bhubaneswar.
 - 2.2 "The Engineer" shall mean the Engineer appointed by the Purchaser for the purpose of this contract.
 - 2.3 "Purchaser's Representative" shall mean any person or persons or consulting firm appointed and remunerated by the Purchaser to supervise, inspect, test and examine workmanship and materials of the equipment to be supplied.
 - 2.4 "The Contractor" shall mean the bidder whose bid has been accepted by the purchaser and shall include the bidder's executives, administrators, successors and permitted assignees.
 - 2.5 "Contract Price" shall mean the sum named in or calculated the bid.
 - 2.6 "General Condition" shall mean these General Terms and Conditions of Contract.
 - 2.7 The Specification" shall mean both the technical as well as commercial parts of the specification annexed to or issued with GTCC and shall include the schedules
 - 2.8 "Month" shall mean "Calendar month".
 - 2.9 Writing" shall include any manuscript, type written, printed or other statement reproduction in any visible form and whether under seal or under hand.
 - 2.10 "FOR Destination costs" shall mean the cost at our work site. The cost is inclusive of all taxes & duties etc., but excluding Service tax.
 - 2.11 The term "Contract document" shall mean and include GTCC, specifications, form of tender, Notice Inviting Tender, covering letter, schedule of prices or the final General Conditions, any special conditions, applicable to the particular contract.
 - 2.13 Terms and conditions not herein defined shall have the same meaning as are assigned to them in the Indian Contract Act, failing that in the ODISHA General Clauses Act.

3. Manner of execution:

Construction of retaining wall around the switch yard of grid substation Kendrapada as per the specification and providing wiremess fencing including supply of all the materials like GI angle, GI flat, GI hexagonal wire mess, Barbed wire etc and take up the work as per instruction of Engineer – in – charge.

4. PERIOD OF EXECUTION:- The work shall be carried out and completed in all respect within 90 days from the date of issue of this work order.

5.<u>INSPECTION</u>: Necessary inspection will be done by the consignee/ Supervising officer during execution of work. The fencing materials are to be inspected by the engineer in charge before taking up the work

4. **Language and measures**:

All documents pertaining to the contract including specifications, schedule, notices, correspondence, operating and maintenance instructions or any other writing shall be written in English language. The metric system of measurement shall be used exclusively in this contract.

5. Right to reject/accept any tender:

The Purchaser reserves the right either to reject or to accept any or all tenders if the situation so warrants in the interest of the OPTCL. Orders may also be split up between different Tenderers on individual merits of the Tenderer. The Purchaser has exclusive right to alter the quantities of work at the time of placing final work order.

6. **COMPENSATION:** - The contractor shall be fully responsible for paying

compensation, if any under the Workmen Compensation Act on account of workmen deployed by him. He must have followed all the safety rules and provide all the required protective equipments to his workmen as they are to work in a surroundings of Extra High Voltage System. OPTCL in no way will be responsible for payment of any compensation.

7. **Force Majeure**:

The Contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force majeure such as acts of god, acts of the public enemy, acts of Govt., Fires, floods, epidemics, Quarantine restrictions, strikes, Freight Embargo and provided that the Contractor shall within Ten (10)days from the beginning of delay on such account notify the purchaser in writing of the cause of delay. The purchaser shall verify the facts and grant such extension, if facts justify.

8. Extension of time:-

If the Completion of work is delayed due to reasons beyond the control of the Contractor, the Contractor shall without delay give notice to the purchaser in writing of his claim for an extension of time. The Purchaser on receipt of such notice may or may not agree to extend the contract period date as may be reasonable but without prejudice to other terms and conditions of the contract.

9. Guarantee period: -

The guarantee period for this contract shall be One Year. Any defect/ deviation if noticed during this period shall be immediately rectified free of cost on written notice from the consignee failing which the security deposit shall be forfeited

10. <u>SERVICE TAX REGISTRATION No., PAN CARD & CIVIL LICENSE:</u>

Clear attested Xerox copies of PAN No./ Valid VAT registration & clearance certificate/Civil contractor license issued by Govt of Odisha/Railways /Military, service tax registration number (if applicable) valid on the date of opening of tender should be submitted along with tender, without which tender will be rejected. The Contractor may be requested to produce original PAN card, VAT registration, VAT clearance certificate, Service Tax registration number as applicable & Civil contractor license and all other relevant documents for verification. Those who fail to produce the same and found not to be valid on the date of opening of tender, their tenders will be rejected.

11. Security deposit towards, 100% payment and performance guarantee:

The successful tenderer will be required to deposit a sum amounting to 10% of value of the contract in shape of Bank Draft / B.G from any nationalized bank (as per the prescribed format) valid up to two months after the guarantee period drawn in favour of the paying officers within 15 days of receipt of the work order. In the event of any breach or default in all or any conditions of the work order, the G.M., EHT (O&M) Circle, Cuttack may forfeit the whole amount of Security deposit. No interest will be paid on the security deposit so deposited by the contractor and will be released after expiry of the guarantee period by the paying officer. The security value must be deposited prior to execution of work.

12. Terms of Payment.

90% of the Contract Value in respect of the Erection and supply component shall be paid as per the actual work done basing upon the Joint Measurement Certificate. Balance 10% shall be paid after successful completion of the work , subject to approval of the Guarantee Certificate by the Ordering Authority.

The above payments are subject to submission of the Contract Security-cum-Performance Guarantee by the contracted firm as per Clause 2 of Section-II of the tender specification.

Deduction of Income Tax & Work Contract Tax and reimbursement of Service Tax shall be as per the prevailing norms of OPTCL

13. Penalty for Delay in Completion of Contract

Penalty shall be imposed @ ½% (half percent) of contract price for each calendar week of delay of part thereof subject to maximum of @ 5% (five percent) of contract amount. Charges towards penalty shall be counted after scheduled date of completion/issue of clear instruction to the contractor for commencement of works by the General Manager, E.H.T (O&M) Circle, Cuttack /concerned Asst. General Manager, (O&M) Divisions.

14. Validity.

Prices and conditions contained in the offer should be kept valid for a minimum period of 180 days from the date of opening of the tender, failing which the tender shall be rejected.

17. Outright Rejection of Tenders

Tenders shall be out rightly rejected if the followings are not complied with.

TECHNICAL SPECIFICATION

- 1. **The Scope of work:** The scope of works covers the following works.
 - i. Construction of RCC retaining wall as per the schedule of quantity around the switch yard.
 - ii. Supply and fixing of fence post made of 65 x 65 x 6 mm hot dip G.I. angle each of length 3.5 mtr long and. The base of angles is to be grouted up to 1 mtr in the concrete base of the retaining wall. The scope of work covers supply of GI barbed wire (specify size) and fixing of the same in four layers on top of the fencing post and supply and fixing of welded hexagonal GI wire mesh (8 SWG) of height 2 Mtr. The scope of work also includes supply of 50 x 6 mm G.I. Flat which is to be welded both on top and bottom of the wire fence for strengthening as well as earthing purpose and connection of the same to the earth mat. All material supply and erection works shall be strictly as per the enclosed drawing.

All required Materials will be supplied by the Contractor and are to be purchased from reputed manufacturer. The required tools and tackles, skilled man power for execution of the work will be supplied by the contractor. OPTCL shall in no way be responsible for any type of accident/ loss of the contractor and no compensation in this regards shall be borne by the OPTCL. Damage to OPTCL property by the Contractor during execution of work will be recovered from the bill of the contractor.
