- 5. The sale & receipt of the Bid documents shall start from dtd 24.12.2016 and close on dtd 02.01.2017 at 2.00 PM. The Bid shall be received in all offices as well as office of the undersigned where the bids have noticed to be sold.
- 6. Bid must be delivered in the tender box having identification NO. E.E. CWD- 0-21/16-17
- 7. Bid document can be purchased from all offices mentioned in the table column 4 against a nonrefundable fee towards cost of the documents as indicated in column 6 of the table in cash or DemandDraft issued from any Scheduled Bank payable at Bhubaneswar in favor of Executive Engineer, Civil WorksDivision NO-I, OPTCL, BBSR.
- 8. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs. 500.00 over cost of documents. The Executive Engineer, Civil WorksDivision NO-I, OPTCL, BBSR will not be held responsible for the postal delay if any in the delivery of the documents or non-receipt of the same in time.
- 9. The Bids will be opened on dated 03.01.2017 at 11.30 A.M. in the office of the undersigned in the presence of the bidders or their authorized agent who wish to attend. If the office happens to be closed on the last date of sale/receipt and opening of the bids as specified the bids will sold/received and opening on the next working day at the same time and venue.
- 10. The bidders shall furnish the copies of all valid registration certificates, PAN Card,up to date Valid VAT clearance, Service Tax Registration Certificate issued for works contract services/civil construction services, Xerox or original copy of money receipt along with the Bid failing which his/her bid shall not be considered.
- 11. All the facilities as per Notifications/circulars / orders of Government / OPTCL will be available to the eligible Bidders
- 12. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
- 13. Other details can be seen in the bid documents.
- 14. The amount tendered is excluding of service tax. While passing bills, service tax to be included at the applicable rates observing reverse charge procedure in the bill. The contractor have to deposit the service Tax amount which are paid by OPTCL along with the contractor bill to the respective Govt Dept within due date and time.
- 15. The bidder whose quoted rate is less than the estimated cost by more than 14.99 % will be rejected. The bidder who have quoted less bid price / rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount in shape of DD / TDR pleadged in favour of EE, CWD-1, OPTCL, BBSR failing which the bids will be rejected.
- 16. If any bonafide mistake or omission in the wording ,description of item,unit,quantity and any clause in TCN / Tender schedule / Tender paper document is left unnoticed & inadvertently & the same is detected after sale of the bid document, then the Tender inviting authority i.e. the Executive Engineer, Civil Works Division No.I, OPTCL, Bhubaneswar reserves every right to correct that and all purchasers will abide by that correction.
