

## **INSTRUCTION TO TENDERERS**

Sealed tenders are invited in duplicate for supply of digital meters 96mm<sup>2</sup> 1 Amp auxiliary 220 V D.C of A.E/Secure make required for commissioning 315 MVA ICT-I & II at 400/220 KV New Duburi Grid S/s as per specification each complete with all details in the manner here-in-after specified, with tender form duly signed along with the tender and in double sealed covers, superscribed on the cover with tender specification No. & due date of opening as explained in clause-9 of this section, are invited by the General Manager (Elect.), E.H.T. Construction Circle, Bhubaneswar from the eligible suppliers / registered firms / manufacturers / authorised dealers so as to be received by the office of the General Manager (Elect.), E.H.T. Construction Circle, OPTCL, Qr.No.C-5/1, GRIDCO Colony, Bhoinagar, Bhubaneswar by 3:00 P.M. of 20.04.2013 in accordance with tender Specification No. G.M., EHT(C) CIRCLE-BBSR-10/2012-13 which can be obtained from the office of the General Manager (Elect.), E.H.T. Construction Circle, Bhubaneswar during office hours from 10.30 A.M. to 3.00 P.M. of 10.04.2013 to 18.04.2013 on payment of Rs.1,575/- (Rupees One thousand five hundred seventy five) only by Demand Draft drawn in favour of "E.H.T. Construction Circle, OPTCL, Bhubaneswar" on any Nationalized Bank payable at Bhubaneswar. The intending bidders, who want to get a copy of the Tender Specification by post, are required to deposit an additional amount of Rs.100/- (Rupees one hundred) only over and above the cost of Tender Specification to cover the postal charges. OPTCL shall not be responsible for any postal delay at any stage.

- 1. The purchaser may alter the quantities of material at the time of placing order. Order may also be split up among more than one tenderer.
- 2. Tender will be opened in the office of the General Manager (Elect.), E.H.T. Construction Circle, Qr.No.C-5/1, GRIDCO Colony, Bhoinagar, Bhubaneswar at 3.30 P.M. on **20.04.2013** in the presence of the tenderers or their authorized representatives who may be required to produce their letter of authorization, failing which they may not be allowed.
- 3. Only those who have purchased the specification can submit their tenders.
- 4. The Purchaser reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.

- 5. A) Tenders shall be submitted in person or by Registered post with A.D. Any other means of delivery shall not be accepted. When submitted by Post, delay in delivery by them shall not be condoned. When delivered in person, the tenders shall be received by a responsible officer of the office of the purchaser who shall officially acknowledge the receipt of the same. Tenders received after due date & time shall not be considered.
  - B) Telegraphic tenders will not be entertained.

- The tender shall be accompanied with 1% amount of the tendered value as Earnest Money in shape of Demand Draft drawn in favour of "E.H.T.(C) Circle, OPTCL, Bhubaneswar." on any Nationalized Bank payable at Bhubaneswar failing which the tender will be rejected.
  - ii) Small Scale Industries within the State of Orissa holding permanent Registration Certificate issued by the Director, Export Promotion and Marketing, Govt. of Orissa are exempted from payment of Earnest Money Deposit, if documentary proof of registration with Director or E.P.M. for manufacturer of materials included in the specification accompanies the tender documents and registration is valid on the date of opening of tender.

The tender will be rejected **REPEAT REJECTED** if the authenticated proof of registration is not furnished in case of claiming exemption of E.M.D.

Authenticated proof used in the above clause means Photostat copy of registration or copy of registration attested by the District Industries Officer. This should specifically show that they are registered to manufacture the item covered in the specification as the end product.


iii) Firms registered under D.G.S. and D. for the materials covered in the specification are exempted of earnest money provided authenticated proof of such registration accompanies the tender documents and the registration is valid on the date of opening of tender.

The tender will be rejected REPEAT REJECTED if the proof of registration is not furnished in case of claiming exemption of E.M.D.

Authenticated proof used in this clause means Photostat copy of registration only.

- iv) The self employed entrepreneurs registered with (N.S.I.C.) National Small Industries Corporation and who are in receipt of assistance either from the Government or Nationalized Banks or institutions under the administrative control of the Govt. are exempted from payment of earnest money on submission of following documents along with their tenders.
  - a) Photostat copy of valid N.S.I.C. Certificate of Registration, which should cover the item for which they submit tender.
  - b) Documentary proof of assistance received by a self-employed entrepreneur from the authorities concerned.

- v) All Government undertakings are exempted from payment of Earnest money deposit. They should submit authentic proof in support of the same.
- vi) In the case of unsuccessful tenderer, the earnest money will be refunded after the tender is decided. In the case of successful tenderer the earnest money will be taken into account in arriving at the Security Money referred to in Clause- (9) of Section-II General Condition of Contract.
- vii) Earnest Money will be forfeited if the tenderer fails to execute the purchase order issued in his favour for the quantities decided in his favour in full or part.
- 7. The Tenders should be valid for a period of 120 days from the date of opening the tender, failing, which the tenders will be, rejected **REPEAT REJECTED**.
- 8. Tenderers are expected to be fully conversant with the meaning of all the clauses of the specification before submitting their tenders. In case of doubt regarding the meaning of any clause the tenderer may ask for clarification from the General Manager (Elect.), E.H.T. Construction Circle, Bhubaneswar. This however does not entitle the tenderers to ask for time beyond the due date fixed for receipt of tender.
- 9. Tenderers are required to submit the tender in duplicate in separate sealed covers superscribed as "Tender Specification No.GM-EHT(C) Circle-BBSR-10/2012-13". The above two sealed covers should be placed in an outer sealed cover duly superscribed as "Tender Specification No.GM-EHT(C) Circle-BBSR-10/2012-13 due to be opened on Dt.20.04.2013 at 3.30 P.M". The Tender shall contain the following documents.

## <u>SECTION – II</u>

# **GENERAL CONDITIONS OF CONTRACT**

- 1. **Scope:** The specification covers the rating, make & manufacturer, testing of materials before despatch and delivery at destination within Odisha State.
- 2. **Drawing & Descriptive Literatures:** The materials should be as per our specification.
- 3. Samples and Test Certificates: The materials has to be submitted by the successful tenderer for approval within 10 days of issue of the purchase order failing which the order is liable for cancellation. The procurement of materials / meters should be taken up after approval of sample by the competent authorities.
- 4. **Standards:** The materials should confirm to the latest publications of relevant I.S.S.
- 5. **Guarantee:** The materials should be guaranteed for satisfactory operation for a period of at least 18 months from the last date of supply or 12 moths from the date of use whichever is earlier. Any defect noticed during the period should be rectified by the supplier free of cost provided such defects are found to be due to faulty design, bad workmanship or bad materials used. Otherwise the security deposit shall be forfeited.

The tenders should guarantee the following among other things.

- i) Quality and strength of materials used.
- ii) Safe mechanical strength of all parts of materials as required under relevant I.S.S.
- iii) Satisfactory operation during guarantee period.
- 6. **Price**: The price should be FIRM, FOR delivery at our designated stores at Duburi including packing, forwarding, freight, insurance, sale tax / VAT, excise duty and any other taxes / duties etc. The breakup of FOR destination price as per schedule of prices at Annexure-VI must be submitted along with the tender. Any price other than FOR destination price as mentioned above shall not be considered.
- 7. <u>Terms of Payment</u>: 100% payment of the total contract value of the materials delivered along with the Sales Tax / VAT and other taxes as per contract shall be made within one month of receipt of materials along with relevant documents at site in good condition and verification there of subject to approval of Performance Guarantee Certificate & Test Certificates and deposit of 5% of contract value towards security & performance guarantee as per clause-9.


- 8. Delivery and Penalty: Delivery of the materials covered under this specification shall commence within 30 (thirty) days and shall be completed within 45 (forty five) days from the date of issue of Purchase Order. The detail delivery program shall be mentioned in the purchase order. If the delivery is delayed beyond the stipulated delivery period, penalty @ half percent of the contract value of the undelivered materials per week subject to a maximum of 5% of the contract price of the same shall be levied.
- 9. Security Deposit: -The successful tenderer, within 7 days of issue of purchase order, will be required to deposit a sum amounting to 10% of the total amount of the purchase order, which shall be retained till the end of performance guarantee period as per clause-5, in any of the approved forms viz- Demand Draft for successful execution of purchase order and also security deposit towards satisfactory performance. Security Deposit offered in shape of Demand Draft should made payable to the "E.H.T. Construction Circle, OPTCL, Bhubaneswar" drawn on any Nationalized Bank payable at Bhubaneswar.

Small Scale Industries of Odisha registered with the Director of E.P.M. Odisha shall be exempted from payment of Security Deposit.

All Government undertakings whether of Central or State shall be exempted from payment of Security Deposit.

- 10. No interest is payable either in the case of Earnest money or Security Deposit. Security Deposit will be forfeited if the successful, tenderer fails to execute the order placed on him.
- 11. **Inspection:** The materials will be inspected by the Inspecting Officer authorized by this office from time to time prior to their despatch to destinations. Intimation about readiness of materials for inspection and despatch should be intimated at least 5 days in advance. The Supplier shall offer all facilities to the Inspecting Officer for such inspection at their works. If the Purchaser has reasons to doubt the adequacy of the Suppliers testing facilities, the tests may be conducted at any other test house approved by the Purchaser. Cost of such testing shall be borne by the Supplier.
- 12. **Jurisdiction of Court:** Suits if any, arising out of this contract shall be filed by either party in a court of law to which the jurisdiction of High Court of Odisha extends.
- 13. Sales Tax / VAT clearance & ITCC / PAN No.: Sales Tax / VAT clearance certificates valid on the opening date of tender & ITCC / PAN No. should be enclosed with the tender.

- 14. **<u>Right to Reject / Accept any Tender</u>:** The purchaser reserves the right either to reject or accept any or all tenders. Orders may also be split up between different tenderers in individual merit of the tenders. The purchaser has exclusive right to alter the quantities of materials at the time of placing final purchase order. After placing of the order the purchaser may defer the delivery of the materials. It may be clearly understood by the tenderer, that the purchaser need not assign any reason for the above sections.
- 15. **Contractors/Suppliers responsibility:** Non-withstanding any thing mentioned in the specification or subsequent approval or acceptance of the purchase, the ultimate responsibility of the design, materials used and satisfactory performance shall rest with the tenderer.
- 16. **Cancellation:** In case the supply is delayed partly or fully by more than 4 (four) weeks, the purchaser shall have the right to cancel the purchase order without further notice to the supplier and the supplier shall have no claim to compensation in any ground.
- 17. **Consignee:** The consignee for the material detail of which will be confirmed through Purchase Order.
- 18. **Despatch Instruction:** The materials shall be despatched to consignee only with proper packing as per I.S.S. as per despatch instruction mentioned in the purchase order.
- 19. **Paying Officer:** -Bills in triplicate clearly marked as **"Original", "Duplicate", "Triplicate",** shall be furnished to the Paying Officer. The name of the Paying Officer shall be confirmed through Purchase Order.


