

INSTRUCTION TO TENDERERS

SECTION-I.

INSTRUCTION TO TENDERERS

 The bidders must read in detail the "Instruction to Bidder", "General terms and conditions" and "Technical Specification" before filling the Tender documents. There are four sections in this Tender Specification.

2. TENDERS:

- Bidders must submit their bids in duplicate with original signature.
- Manufacturers/ Authorized Dealers / registered firms & suppliers / SSI Units are only eligible to quote.
- c) Tender must be submitted in sealed envelopes superscribed as supply of DIFFERENT ELECTRICAL SAFETY EQUIPMENTS i.e. SAFETY SHOES AND SAFETY HELMETS REQUIRED FOR USE DURING ELECTRICAL CONSTRUCTION WORKS OF GRID SUB STATION SWITCH YARD & TRANSMISSION LINES against Tender Call Notice No.02/2014-15, due on dt.07.06.2014 for opening and addressed to General Manager, EHT (Const.) Circle, Bhubaneswar.
- d) Tender shall be submitted either in person or by Registered post with A.D/courier service. Any other means of delivery shall not be accepted. Detailed postal address with PIN, phone No./FAX No. must be mentioned in the application requesting for Tender document and on the Tender Bid. The Tender submitted in person is to be dropped in the Tender Box. Tender received after due date and time will not be considered. The authority will not be responsible for receipt of Tender after due date and time due to postal delay or any other reasons.
- e) Conditional offers will not be accepted.
- f) If the last date of receipt of tender and its opening is a holiday, it will be received and opened on the next working day in same time.
- g) Bidders may quote for all items or individual items.
- 3. EARNEST MONEY DEPOSIT (EMD): The tender must be accompanied by 1% (one percent) of the tendered value (TOTAL including taxes) as EMD in shape of Bank Draft drawn in favour of EHT (Const.) Circle, OPTCL, Bhubaneswar payable at Bhubaneswar. The EMD of successful Tenderers will not be adjusted towards security deposit and shall be refunded on written request after receipt of security deposit. The EMD of all unsuccessful Tenderers shall be refunded on written request after finalization of Tender. No interest shall be paid on E.M.D. All Govt. undertakings are exempted from payment of EMD. They should submit authentic proof in support of the same.

4. FORFEITURE OF E.M.D.:

- a) In the event the successful Tenderer failing to accept the order or supply the materials as per the technical specification EMD/S.D. so deposited shall be forfeited.
- b) Any deviation from the terms and conditions of the contract awarded, may also lead to forfeiture of EMD without any notice.
- INFORMATION OF COMPETITORS: Bidders have right to know information on competitors
 only at the time of opening of the bids. No further information on competitors shall be provided at
 any other point/stage of the tender without prejudice to Right to Information Act. 2005.

6. OPENING OF TENDERS:-

- a) Copy of up-to-date PAN Card) and VAT Registration & clearance certificate/Manufacturer or Authorized Dealership certificate (wherever applicable) should be enclosed with the tender.
- b) Bidders themselves or their authorized representatives (possessing authorization letter in original) shall be allowed to attend opening event of the tender.
- 7. The purchaser may alter the quantities of materials at the time of placing orders. Orders may also be split up among more than one tenderer for any particular item if necessary. Only those who have purchased the tender specification in the name of their firm from this office can submit their tender.
- The Tenderers may please note that the Word 'item' in the paragraph shall mean the materials /
 equipment as specified in the 'Tender Specification'. In case of deviations, the decision of the
 purchaser shall be final.
- The purchaser reserves the right to reject the lowest or any other tender or all tenders without assigning any reason what so ever.
- 10. Tenders should be prepared clearly and without any overwriting and corrections. Erasures and other changes shall bear the dated initial of the person signing the tender.
- In the event of discrepancy or arithmetical error in the schedule of price, the decision of the purchaser shall be final and binding on the tenderer.
- For evaluation, the price mentioned in words shall be taken if there is any difference in figure and words in the price bid.
- 13. The tenders shall be outright rejected if they do not comply with the following requirements.
- Tenderer should have purchased the relevant tender specification from the office of the General Manager, EHT (Const.) Circle, Bhubaneswar and indicate the money receipt No and date of this Office.
- ii) Tenders shall be submitted in person or by Registered post with A.D/Courier service which should be received before the opening of tender as specified in the tender call notice.
- iii) Tenders shall not be submitted telegraphically or by FAX.
- iv) Tenders shall be accompanied with the prescribed earnest money deposit/attested Xerox copies of proof of exemption for furnishing the E.M.D. if any.
- v) Tenders shall be kept valid for a minimum of 120 days from the date of opening of the tender.
- vi) The tender shall not be conditional.
- vii) In case of authorized dealer, necessary authorized dealership certificate should be submitted along with the tender duly issued by the manufacturer which should be valid on the date of opening of the tender. The registered suppliers have to mention the name of the manufacturer in their tender. In case of SSI Units, necessary certificates may also be furnished along with the tender.
- viii) Violation of terms and conditions set forth and provided in the tender specification.

- Non submission of attested copies of I.T. Pan card, valid VAT registration certificate and VAT clearance certificate.
- x) The tenderer shall submit the guaranteed technical particulars of each items quoted.
- xi) The tenderer shall submit the technical literature & manufacturer's price list of each item.
- xii) The tenderer shall submit at least one sample of each item quoted.
- xiii) The bidder shall agree to supply the material within the scheduled delivery period.
- xiv) The bidder shall submit of duly filled up abstract of terms and condition (Section-IV).
- xv) If the tender documents / specification will be downloaded from OPTCL website for which Rs.1,575/- only including VAT 5% will be deposited in shape of D.D drawn in favour of E.H.T.Const. Circle, OPTCL, Bhubaneswar & to be furnished the same separately with the tender specification.
- xvi) SSI Units within the State of Odisha holding permanent Registration Certificate issued by the Director, EP&M, Odisha are exempted from payment of EMD, if documentary proof of Registration with Director, EPM for manufacturer of such materials included in the specification accompanies the tender documents & Registration is valid on the date of opening of tender.
- xvii) Firms registered under DGS&D for the materials covered in the specification are exempted of earnest money provided authenticated proof of such registration accompanies the tender documents & the registration is valid on the date of opening of tender.

GENERAL CONDITION OF CONTRACT

- SCOPE OF CONTRACT: The scope of contract shall be to deliver the material free on Rail/Road transport at destinations of OPTCL site at S.D.O (Elect.), EHT (C) Sub-Divn., No.I, Bhubaneswar as per the schedule of quantities mentioned in the price schedule. The tenderer should mention the name of the manufacturer of the item, submit guaranteed technical particular of each items in line with the technical specification, technical literature of the manufacturer and manufacturer's price list OPTCL LOGO, month and year of manufacturer shall be printed on each item.
- 2. PRICE: The price should be firm and FOR destination at S.D.O (Elect.), EHT (C) Sub-Divn., No.I. Bhubaneswar by rail/road transport. The price should be inclusive of packing, forwarding, freight, insurance charges, excise duty, and other taxes if any. VAT if extra, shall be paid to the Purchaser as per actual against production of documentary evidence. The amount & nature of taxes should be clearly specified in the price schedule. The bidder may also quote in C.S.T. Mode and in that case necessary 'C' form should be provided by the respective Divisions.
- DELIVERY: The materials shall be supplied within 60 days from the date of issue of purchase order. The purchaser however reserves the right to reschedule the delivery, change of destination.
- VALIDITY: Price with terms and conditions of the offer shall be valid for a minimum period of 120 days from the date of opening of tender failing which their tenders will be rejected.
- 5. INSURANCE: Insurance of materials is to be done by the supplier at his own cost. The responsibility of delivery of the materials at destination in good condition rests with the supplier. Any claim with the insurance company Railway authority/Road transport authorities arising due to loss or damage in transit has to be settled by the supplier. The supplier shall undertake free replacement of materials damaged or lost which will be reported by the consignee within 30 days of the receipt of the materials at destination without waiting for the settlement of the claims with the carriers and underwriters.
- DESPATCH INSTRUCTIONS: The materials should be securely packed and dispatched by Rail/Road transport. Detailed instruction regarding dispatch of materials of OPTCL stores of Grid Sub Station will be indicated at the time of placing order.
- 7. TERMS OF PAYMENT: 100% payment with taxes & duties will be paid after delivery of materials at the respective sites subject to inspection and detailed verification thereof subject to deposit of security amount & approval of guarantee & test certificate.
- 8. PENALTY FOR DELAY IN DELIVERY: If the supplier fails to deliver and/or install the materials within the delivery period as stipulated under Clause No.3 (Section-II) of this tender document or any extension granted thereto, the purchaser shall recover from the supplier penalty for a sum of half percent (i.e. 0.5 percent) of the contract price for each calendar week or part thereof of delay.

However the total amount of penalty shall not exceed 5% (five percent) of the cost of undelivered items. Materials will be deemed to have been delivered only when all the component parts are delivered. If certain components are not delivered in time, the supply will be treated as delayed until such time the missing/undelivered parts are delivered.

- 9. EXTENSION OF TIME: If the delivery of materials are delayed due to reason beyond the control of supplier, the supplier shall without delay give notice to the purchaser in writing for an extension of time with detail justification. The purchaser on receipt of such notice may agree to extend the contract delivery date if reasonable but without prejudice to other terms and conditions of this contract.
- 10. GUARANTEE PERIOD: The safety items are to be guaranteed (jointly by the Manufacturer and bidder) for trouble free service for a period of 18 month from the date of supply or 12 months from the date of installation. Any defect if noticed during the above guarantee period shall be replaced/ rectified by you of free of cost provided such defects are traced due to bad material, bad workmanship & faulty design etc. The above guarantee certificate in triplicate must be furnished to this office for approval to the under signed by the successful bidders.

The tender shall be accompanied with dimensional drawing and technical literature, leaflets, manuals if any.

14. FREE REPLACEMENT: Free replacement of materials lost/damaged due to transit shall be made immediately on receipt of the intimation from the consignee/Paying Officer without awaiting for settlement of the claim of bidders with Railway/Lorry/Insurance Company.

- 15. SECURITY DEPOSIT CUM- PERFORMANCE GUARANTEE: Security Deposit-cum-Performance Guarantee amounting to 10% of the contract value valid up to two months after the guarantee period shall be deposited within 15 days (fifteen days of placement of Purchase order in the shape of D.D/Composite B.G. from a Nationalized Bank drawn in favour of EHT (Const.) Circle, OPTCL, Bhubaneswar which will be refunded after two months of completion of the Guarantee period on written request. The B.G. format will be issued by the purchaser. In the event of any breach or default in all or any condition of Purchase Order, the security deposit cum performance guarantee will be forfeited. The B.G. shall be approved by the undersigned.

- 17. JURISDICTION OF COURT: For the purpose of jurisdiction of Court in the event of any dispute shall be deemed to have entered into any Court of law at Bhubaneswar to which the jurisdiction of Odisha High Court extends and it is hereby expressly agreed that neither party shall be competent to bring a suit in regard to the matter covered by this purchase at any place outside in State of Odisha.
- QUANTITY VARIATION: The quantity to be ordered may undergo revision at the time of placement of orders.
- 19. Order may be split between bidders if required.
