The undersigned invites sealed tenders exclusively from the firms empaneled under the prevailing Rate Contract of OPTCL for Normal / Emergency Substation & Line Works, for execution of the works mentioned under subject on partial turnkey basis (i.e. a part of the material requirement is to be procured by the contracted firm from the approved vendors of OPTCL in addition to the erection works). Settlement of ROW disputes and payment towards compensation claims shall also be covered under the scope of the contract. The bidders are advised to refer to the tower schedule, profile drawing & land schedule available in the office of AGM(Elect), EHT (C) Division, Cuttack and make a site visit for assessment of scope of works as well as probable ROW issues.

The soft copy of the tender specification may be obtained from the office of the undersigned during 11 AM – 5 PM of working days from 29.05.2013 to 11.06.2013. The tenders shall be received up to 1 PM on 12.06.2013 and be opened at 3:30 PM on the same date in presence of the bidders or their authorized representatives. A pre-bid meeting is scheduled to be held on 05.06.2013 at 3:30 PM for clarification of any issues relating to the tender and amendment of the tender specification, if so required.

Tender duly filled in and signed / sealed on each page by the authorized signatory should be submitted in sealed envelope superscribed with the Tender Specification No. and addressed to Senior General Manager (TP&C), OPTCL, either in Person or through Registered Post / Speed Post (with A.D.). Cost of the tender document (i.e. Rs10,000/- plus 5% VAT) and Earnest Money Deposit (@ 1% of the bid value) in shapes as prescribed in the tender specification must be accompanied with the tender document, the non-compliance of which shall make the tender liable for disqualification.

If the scheduled last date of receipt of tenders happens to be a holiday, the cut-off schedule for receipt / opening of tenders shall be shifted to the same time of the following working day. Tenders received after the cut-off date & time are not acceptable irrespective of the reasons of delay.
