The bidders shall furnish the attested copies of all valid registration certificates, PAN Card, Valid VAT clearance, Service Tax Registration Certificate, Xerox nor original copy of money receipt along with the Bid failing which his/her bid shall not be considered. The bidders shall have to $f\psi$ rnish an affidavit for the particular work at the time of submission of the bid about the authentication of all the tender documents including E.M.D. failing the bid shall be considered as non-responsive and thus liable for rejection.
