## 1. DEFINITION OF TERMS:

i. For the purpose of this specification and General Terms and Conditions of contract [GTCC], the following words shall have the meanings hereby indicated, except where otherwise described or defined.

iii. "The Engineer" shall mean the Engineer appointed by the Purchaser for the Purpose of this contract.
iv. "Purchaser's Representative" shall mean any person or persons or consulting firm appointed and remunerated by the Purchaser to supervise, inspect, test and examine workmanship and materials of the equipment to be supplied.
v. "The Contractor" shall mean the bidder whose bid has been accepted by the purchaser and shall include the bidder's executives, administrators, successors and permitted assignees.
vi. "Contract Price" shall mean the sum named in or calculated the bid.
vii. "General Condition" shall mean these General Terms and Conditions of Contract.
viii. The Specification" shall mean both the technical as well as commercial parts of the specification annexed to or issued with GTCC and shall include the schedules.
ix. "Month" shall mean "Calendar month".
x. Writing" shall include any manuscript, type written, printed or other statement reproduction in any visible form and whether under seal or under hand.
xi. "FOR Destination costs" shall mean the cost at our work site. The cost is inclusive of all taxes \& duties etc., but excluding GST.

## 2. PRICE:

1. The price quoted should be firm, F.O.R. destination inclusive of freight, Insurance, Packing, Forwarding charges inclusive discount if any.
2. Taxes, if any shall be mentioned extra. The Tenderer may quote rate in respect of different make materials as per scheduled.
3. LANGUAGE \& MEASURES:

All documents pertaining to the contract including specifications, schedule, notices, correspondence, operating and maintenance instructions or any other writing shall be written in English language. The metric system of measurement shall be used exclusively in this contract.

## 4. RIGHT TO REJECT/ ACCEPT ANY TENDER:

The Purchaser reserves the right either to reject or to accept any or all tenders if the situation so warrants in the interest of the OPTCL. Orders may also be split up between different Tenderers on individual merits of the Tenderer. The Purchaser has exclusive right to alter the quantities of work at the time of placing final work order.

## 5. COMPLETION OF WORK:

The works awarded should be commenced from 15 days of the award of the contract and to be completed within 60 days after issue of work order.

## 6. FORCE MAJEURE:

The Contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force majeure such as acts of god, acts of the public enemy, acts of Govt., Fires, floods, epidemics, Quarantine restrictions, strikes, Freight Embargo and provided that the Contractor shall within Ten (10) days from the beginning of delay on such account notify the purchaser in writing of the cause of delay. The purchaser shall verify the facts and grant such extension, if facts justify.

## 7. EXTENSION OF TIME:

If the Completion of work is delayed due to reasons beyond the control of the Contractor, the Contractor shall without delay give notice to the purchaser in writing of his claim for an extension of time. The Purchaser on receipt of such notice may or may not agree to extend the contract period date as may be reasonable but without prejudice to other terms and conditions of the contract.

## 8. GUARANTEE PERIOD:

i) The work done by the contractor shall be guaranteed for a period of 12 months from the date of completion of work against any bad materials used and bad workmanship done for the work. The above guarantee certificate shall be furnished to the ordering authority for his approval. Any defects noticed during this period shall be rectified by the contractor, free of cost to OPTCL within one month, upon written notice from OPTCL provided such defects are due to bad materials used and bad workmanship failing which the security deposit/BG will be forfeited
ii) The work failed or found defective during the guarantee period shall have to be guaranteed after rework for a further period of 12 months from the date of completion of work. The Bank Guarantee is to be extended accordingly without any financial burden to OPTCL.

## 9. GST REGISTRATION NO., PAN CARD, CIVIL LICENSE \& EHT/HT LICENSE:

b. If the executing agency fails to supply the Materials/Equipment or fails to complete the erection including civil works within the due date of agreed key mile stones as defined in the Works Completion Schedule, OPTCL shall have the right to reduce price @ $0.5 \%$ for each week of delay or part thereof limited to maximum of $5 \%$ of the cost (exclusive of GST) of the undelivered portion of the materials/equipment and incomplete portion of works.

It is clearly understood that the Partner in -charge (Lead Partner) shall ensure performance of the contracts (s) and if one or more Partner fail to perform their respective portion of the contracts (s), the same shall be deemed to be a default by all the partners.

It is expressly understood that this power of Attorney shall remain valid binding and irrevocable till completion of the Latent Defect Period in terms of the contract.

The Joint Venture/Consortium partners hereby agree and undertake to ratify and confirm all the actions whatsoever the said Attorney/ Authorised Representative / Partner in-charge takes.

It is proposed on behalf of the Joint Venture/Consortium by virtue of this Power of Attorney and the same shall bind the Joint Venture/Consortium as if done by itself.
