- 4. Bid must be accompanied by E.M.D./Security of the amount specified for the work at column 5 in the above table in shape of NSC/KVP/Postal Savings Pass Book/TDR of any Scheduled Nationalised Bank duly pledged in favour of Executive Engineer, Civil Works Division No-I, OPTCL, BBSR.
- 5. The sale & receipt of the Bid documents shall start from dtd 5:11.2019 to dtd 18.11.2019 up to 5.00 PM .The Bid shall be received in all offices as well as office of the undersigned where the bids have noticed to be sold.
- 6. The Bids will be opened on 19.11.2019 at 11.00 A.M. in the office of the undersigned in the presence of the bidders or their authorized agent who wish to attend. If the office happens to be closed on the last date of sale/receipt and opening of the bids as specified the bids will sold/received and opening on the next working day at the same time and venue.
- 7. Bid must be delivered in the tender box having identification NO. E.E. CWD- TCN-07/19-20
- 8. Bid document can be purchased from all offices mentioned in the table column 4 against a nonrefundable fee towards cost of the documents as indicated in column 6 of the table in shape of DemandDraft issued from any Scheduled Bank payable at Bhubaneswar in favor of M/S Civil Works Division, OPTCL, BBSR. Tender papers will not be issued if payment is made in cash.
- 9. Bidding documents requested by mail will be dispatched by registered/speed post on paymentof an extra amount of Rs. 500.00 over cost of documents. The Executive Engineer, Civil WorksDivision NO-I, OPTCL, BBSR will not be held responsible for the postal delay if any in the delivery of the documents or non-receipt of the same in time.
- 10. The bidders shall furnish the copies of all valid Contract Registration certificates, PAN Card, GST certficate, Xerox or original copy of money receipt along with the Bid failing which his/her bid shall not be considered.
- 11. The contractor shall have to submit copies of valid EPF and ESI certificates issued from the competent authority along with the tender. Those contractors who do not have valid EPF or ESI Regd certificate sahall have to submit an affidavit with declaration that they do not require EPF or ESI certificates as per prevailing Govt norms along with the tender. Non submission of any documents mentioned above long with tender will be liable for cancelation of tender.
- 11. All the facilities as per Notifications/circulars / orders of Government / OPTCL will be available to the eligible Bidders
- 12. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
- 13. Other details can be seen in the bid documents.
- 14. The amount tendered is excluding of GST. While passing bills, GST to be included at the applicable rates observing reverse charge procedure in the bill. The contractor have to deposit the GST amount which are paid by OPTCL along with the contractor bill to the respective Govt Dept within due date and time.
- 15. The amount put to tender is inclusive of 1% cess which will be adjusted during payment of bills . The contractor shall have to produce labour liscence within seven days of agreement if required by the undersigned
- 16. The bidder whose quoted rate is less than the estimated cost by more than 14.99 % will be rejected. The bidder who have quoted less bid price / rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount in shape of DD / TDR pleadged in favour of EE,CWD-1,OPTCL,BBSR at the time of agreement.

17. The Successful contractors shall have to claim for refund of EMD within a period of one year and shall have to claim for refund of Security deposits within a period of three years from the date of completion of contract, Otherwise it will be forfieted.
