1. For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites percentage rate bids in **Double Cover system** for the works through e-procurement as detailed in the table. The bid should be submitted only online in the <http://tendersodisha.gov.in> by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).

2. The bidders may submit bid for the works as per the following table :-

3. Bid documents consisting of specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website <http://tendersodisha.gov.in> as specified at column-8 above.
4. **Bid security declaration- If the bidder withdraws or modifies his bid during the validity period, he will be suspended for a time period of 1 year.**
5. The Bid documents will be available in the <http://tendersodisha.gov.in> from **11.00 Hours of 08.08.2022 to 02.09.2022 up to 17.00 Hours.**

6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class III.
7. Bids shall be received only “**online**” on or before **17.00 Hours of 02.09.2022**
8. The Cover-I (Techno-Commercial Document) of the Bids received “on line” shall be opened at **15.30 Hours on 03.09.2022** in the office of the Superintending Engineer (civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day. The date of opening of CoverII (BOQ) will be communicated in due course of time to the qualified bidders of Cover-I.
9. The bidders shall furnish the attested copies of the valid Contract Licence, Pan, GST, labour licence, Solvency Certificate from a Nationalised /Scheduled Bank issued within last 6 (Six) month , Copy of Balance Sheet and Turn Over for last Three Years(duly certified by a Chartered Accountant along with UDIN), list of works executed with in last three years, list of works in hand along with self-attested copies of supporting documents and Turn Over Certificates for last Five Years(duly Certified by Chartered Accountant with valid UDIN no.),Schedule-A to F & other documents as mentioned in DTCN.
10. **Additional performance security** shall be obtained from the bidder **before drawl of agreement**, he has to submit the Additional Performance Security for the amount as detailed below in Shape of Bank Guarantee/ NSC/KVP/Term Deposit Receipt pledge in favour of **EE,CWD-I, OPTCL, BBSR at the time of agreement.**

11. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.
12. The packet super scribing the name of the work and containing cost of bid document & Affidavit in original and other documents may be submitted in the office of the undersigned on or **before 13.30 Hours on dated 03.09.2022** during office hours on working days failing

which the bid will be rejected

13. The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank, payable at Bhubaneswar **separately** towards cost of each tender. The purchaser of the demand draft has to be the bidder himself or his authorised representative. In case of authorised representative, the bid must be accompanied by a affidavit/undertaking of authorisation.
14. E-Reverse Auction (if applicable) shall be held on www.tenderwizard.com/OPTCL amongst the technically qualified bidders who will be invited as per the terms laid in DTCN.
15. The bidders should have successfully executed/ completed at least a single **similar nature of work, ie, composite work of buildings** worth tender value of **₹ 6.50 Crore or more** during the last five financial years i.e. **2017-22** in a single contract . The bidders failing to produce authenticated document in support of work experience from competent authority is liable for rejection. Experience certificate from any Private Organisation will not be entertained. Experience certificate furnished below the rank of Executive Engineer of Government Department/ Public Sector Undertaking will not be accepted. The original agreement in support of experience certificate submitted by the bidder will be verified before opening of the financial bid.
16. The bidder is required to furnish Solvency Certificate of ₹ 2.00 Crore for work from a Nationalised / Scheduled Bank issued within last Six(6) Months.
17. The bidders are to submit Balance Sheet and Turn Over Certificate of last 05(Five) financial years i.e. from 2017-18, 2018-19, 2019-20, 2020-21 and 2021-2022 duly certified by Chartered Accountant with valid UDIN no.
18. Total Turnover should be **Rs 6.00 Crore** per year or more in an average of last 05 financial years as mentioned above duly certified by Chartered Accountant with valid UDIN no.
19. **EPF and ESI certificate with last 03 month (April to June 2022)** updated challan is mandatory for qualification.
20. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine.
