For and on behalf of OPTCL sealed tenders in duplicate duly superscribed as " Tender Specification No.04/2017-18 are invited from the vehicle owners/ Travel Agencies who do have sound financial capability, experienced driver having valid registration No. of the vehicle with up to date Road Tax & valid 1st party insurance, valid fitness certificate etc and valid IT/PAN for ENGAGEMENT OF THE FOLLOWING DIESEL RUN COMMERCIAL REGISTERED LIGHT VEHICLE having all Odisha route permit for the offices as mentioned below for a period of two years.


"HIRING OF DIESEL RUN COMMERCIAL REGISTERED LIGHT VEHICLE NON A/C BOLERO PLUS ON MONTHLY BASIS WITH DAILY HIRING RATE FOR 220KV TL SUB-DIVISION, THERUBALI UNDER THIS DIVISION FOR THE PERIOD OF TWO YEARS."

The quotation should contain (a) monthly rent (b) Mileage per litre of diesel and (c) mileage per litre of lubricant, preference will be given for new and good conditioned vehicles. The required diesel and mobil (lubricant) will be supplied by the vehicle owner and the cost of such fuel and lubricant only will be reimbursed on submission of monthly bills by producing original fuel vouchers. No other expenditure will be entertained by OPTCL. The consumption of diesel should not be less than 13 Kms per litre and lubricant of one litre mobil oil for every 750 Kms run of the vehicle. The vehicle proposed for engagement on hire basis should not be more than 3(three) years old as on 31.12.2017. Newer vehicle will be given preference over older vehicle.

The bidders are required to produce the copies of the following documents along with quotations and to produce the original documents at the time of opening of tender for verification.

Photocopies of R.C. Book, driving license of driver , valid 1st party insurance coverage, valid non-pollution certificate, PAN / TIN of the agency/ owner valid commercial permit and fitness certificate, GST Registration No.(if any)

The tender should reach this office on or before 01.00PM of dt. 16.01.18 and the same will be opened at 4.00 PM on 17.01.2018. The bidders are required to deposit an amount of 1% of their total quoted rates [i.e. daily quoted rate x 25 days x 24 months (considering average running of 25 days per month)] as EMD in shape of Demand Draft in favour of EHT (O&M) Division, OPTCL, THERUBALI. Incomplete tender and tender without requisite EMD will be rejected. The undersigned reserves the right to accept or reject any or all tenders without assigning any reason thereof.
