SECTION-II

INSTRUCTIONS TO BIDDER

1. Tender must be submitted in sealed cover subscribed as “**Tender call Notice no- 03/2022-23: for PCC and remetalling in 132KV MCL-I & II, TRF-II bay and 132KV Bus- coupler Bay in 132KV S/Y at 132/33 KV Grid S/S, Angul under EHT (O&M)Circle , Chainpal**” on or before 18.06.2022 for opening and addressed to the **General Manager, EHT (O & M) Circle, Chainpal**
2. The contract shall be valid only for a period of 180 days from the date of opening of tender. The department reserves the right also to terminate the contract at any time during the contract period without assigning the reasons thereof.
3. The authority reserves the right to award the contract among any responsive bidders against this tender.
4. Besides this, the authority reserves the right to accept or reject any or all tenders without assigning any reason thereof.
5. The **bidders have to submit all the documents as mentioned in Clause No.1 of SECTION-III**. All the documents must be valid on the date of opening of the Tender and should be submitted along with tenders, failing which the tender will be rejected. The bidder or their authorized representatives should produce the original documents mentioned in Clause No.11 of SECTION-III for verification at the time of opening of the tender. Those who fail to produce the same and found not to be valid on the date of opening of tender not matching with the the Xerox copy submitted by the bidder; their tenders will be out rightly rejected. In case if only one bidder participate in the tender process or nature of urgency of work (decided by this office), then undersigned may consider the case (*but not mandatory) & he will be given a chance to produce original documents in this office within one week from the date of opening of the tender.
6. In case of any dispute arising either in supply of material or any clause of agreement/ work order, the decision of the Unit Head, will be final and binding on the Bidder.
7. Tender with over writing, erased, illegible rates or rates not shown in figures and words in English will be liable for rejection. In case of discrepancy between words and figures noted against each item of the tender and between unit rates and total amount, the decision of the Competent Authority accepting the tender will be final and binding on the bidders. Total of item and grand total of whole tender be clearly written. Correction in the tender, if un-avoidable, should be made by re-writing with dated initial of the bidder after scoring out wrong entries, clerical and arithmetical mistakes may result in the rejection of the tender.
8. The bidders shall sign on all pages of the tender document as a token of acceptance of all terms and conditions thereof and submit his quotations therein.
9. The schedule of prices should be filled up fully to indicate the break-up of the prices including taxes and duties. Incomplete submission of this schedule will make the tender liable for rejection.
10. Request from the bidder in respect of additions alternations, modifications, corrections of either terms or conditions or rates after opening of the tender will not be considered.
11. In the event of discrepancy or arithmetical error in the schedule of price, the decision of the purchaser shall be final and binding on the tenderer. For evaluation, the price mentioned in words shall be taken if there is any difference in figure and word in the price bid.
12. If the rate quoted by the bidder is less than 15% of the estimated cost, the tender will be out rightly rejected and the tender shall be finalized basing on merits of rest bids.If all the bids are quoted at 14.99%(Decimal up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalise the tender through a transparent lottery system, where all bidders/their authorized representatives will remain present

GENERAL TERMS & CONDITIONS OF CONTRACT

Sealed tenders are invited in duplicate from intending Bidders having valid CIVIL Contract License Class (C & B) with PAN and GST Registration for PCC and remounting in 132KV MCL-I & II, TRF-II bay and 132KV Bus- coupler Bay in 132KV S/Y at 132/33 Kv Grid S/S, Angul under EHT (O&M)Circle , Chainpal

1. SUBMISSION & OPENING OF TENDER:-

Tender shall be submitted with other documents in duly sealed envelope super scribed on the body of envelope "Tender for PCC and remounting in 132KV MCL-I & II, TRF-II bay and 132KV Bus- coupler Bay in 132KV S/Y at 132/33 Kv Grid S/S, Angul under EHT (O&M)Circle , Chainpal . The bidder should write only Tender Specification No, the name of work and date of opening of the tender on the body of the sealed envelope. Bidder should not write their name or Agency name on the body of the sealed envelope which may make the offer liable for rejection.

2. RIGHT & AUTHORITY FOR REJECTION:- Tenders received after due date and time will be summarily rejected. The General Manager (Electrical), E.H.T. (O&M) Circle, Chainpal reserves the right to reject any or all of the tenders without assigning any reason thereof.

3. VALIDITY OF OFFER:- The offer should be firm and valid for a period of at least 180 days from the date of opening of tenders. Unless the tender will be rejected.

4. EARNEST MONEY DEPOSIT:- Exempted as per Office Order No. 239 dt 19.04.2022 of CGM(Fin) cum CFO, OPTCL,BBSR till 31.12.2022.

5. PRICE:- The bidders are advised to quote their rate as per the price schedule with break up prices including of all Taxes & Duties and shall remain up to the validity of tenders.

6. SECURITY-CUM-PERFORMANCE DEPOSIT: The successful tenderers will be required to deposit a Security Deposit-cum-Performance Guarantee amounting to 10% of the contract value **valid up to two months after the guarantee period** shall be deposited within 10 days (Ten) days of placement of the Work order in the shape of Cash/DD/Composite B.G. from a Nationalized Bank, drawn in favour of **EHT (O&M) Circle, Chainpal, UCO Bank, TTPS Branch** which will be refunded after two months of completion of the Guarantee period on written request subject to approval of guarantee certificate. No interest shall be paid to the bidder towards the security deposit as deposited by the bidder. The B.G. format will be issued by OPTCL during the placement of the work order. In the event of any breach or default in all or any condition of Work Order, security deposit will be forfeited. In case the security amount is not deposited, the same shall be deducted from the bill of the supplier. **Security Deposit not claimed for refund within three years from the date completion of Guarantee period shall be forfeited**

7. COMMENCEMENT & COMPLETION OF WORK:- The works awarded should be commenced from 15 days of the award of the contract and completed within 60 days from date of award of contract. If the work could not be completed within scheduled date due to any valid reason, then completion period may be extended on written request by the Bidder. If the work will not commence & complete within the stipulated period, then the price reduction will be imposed as per clause No.08 of SECTION-III.

8. **PRICE REDUCTION SCHEDULE:** In case the executing agency fails to complete the entire work within the time specified, OPTCL shall recover from executing agency price reduction schedule for a sum of half%(0.5%) of the taxable value of the contract of the work for each calendar week of delay or part thereof of the entire work. However, the total amount of the price reduction shall not exceed 5% of the taxable value of the contract.
9. **ADDITIONAL PERFORMANCE SECURITY:-** The bidders whose offer qualifies for acceptance will be awarded work order for execution of the works and the bidder shall have to deposit "Additional Performance security" i.e. the differential amount between the quoted price & estimated cost for the said work only if the quoted price is less than the estimated cost (above 5% but below 15%) within seven days from issue of letter from this office in shape of BG/bank draft drawn in favour of EHT (O&M) CIRCLE, CHAINPAL payable at UCO Bank otherwise the bid shall be and next qualified bidder shall be called upon for said work.
10. **TERMS OF PAYMENT: -** -90% payment with taxes and duties will be paid after completion of the work in all respect which shall be certified by the executing officer subject to approval of guarantee certificate and availability of funds and balance 10 % will be paid after completion of Guarantee period.
11. **GUARANTEE PERIOD: -** The work done by the contractor as per contract specification should be guaranteed for satisfactory operation and against any defects, in materials & the workmanship for a period of 12 months from the date of completion of the work. The above guarantee certificate shall be furnished in triplicate to the undersigned for approval. Any defects noticed during the period shall be rectified by the contractors at its own cost, without any financial burden to OPTCL.
12. **DOCUMENTS:-** The following Xerox copy should be submitted with the tender paper & the same will be verified with original documents at the time of opening of tender.

13. **ADDITION OR DELETION OF CONTRACT:-** The Contract may be altered in quantum as per exigencies of work. The bidder shall accordingly provide services as may be required by the Officer-in-Charge on being given a notice of 15 days
14. **ARBITRATION:-** In the event of any dispute arising out of his contract. The same shall be referred for arbitration to the Director (HRD) OPTCL, Bhubaneswar or any arbitrator appointed by the Chairman-Cum- Managing Director, OPTCL after due notice of claim and such appointment and the award of the arbitrator shall be final and binding arbitration and conciliation Act. 1996 shall apply. The venue of arbitration will be Bhubaneswar.
15. **CONSIGNEE:-** SDO, 132/33 KV Grid S/S, Angul.
16. **PAYING OFFICER:-** The DGM, EHT(O&M) Division, Chainpal is the paying Officer for contract..
17. **JURISDICTION OF COURT:-** Disputes if any, arising against the work order to be issued to the Bidder shall be filled by either party in any court of law to which the jurisdiction of Odisha High Court extends. The Authority reserves the right to reject the notice/award the contract among any responsive bidders against the tender or without assigning any reason there of. All other terms and conditions will be governed by OPTCL as per rules.

17. SAFETY PRACTICE:- The Bidder must be followed the OPTCL safety Rule while performing the work. The workmen must provide Safety equipment by the contractor while performing the works .No deviation will be allowed and the consignee has got any power to stop the work at any time on the breach of safety practice.

18. EXTENSION OF TIME:

If the completion of work is delayed due to reason beyond the control of supplier, the supplier shall without delay give justification. The competent authority on receipt of such notice may agree to extend the contract completion date if reasonable but without prejudice to other terms and conditions of this contract.

19. LANGUAGE AND MEASURES:

All the documents pertaining to the contract including specification, schedule, notices, correspondence, or any other writing shall be written in English language. The metric system of measurement shall be used exclusively in this contract unless otherwise any other measuring system is mentioned.

20. CONTRACTOR'S RESPONSIBILITY:

(a) Notwithstanding anything mentioned in the specification or subsequent approval or acceptance by the competent authority, the ultimate responsibility for satisfactory performance shall rest with the bidders.

(b) Clear-cut instructions to be issued to the persons deployed regarding their working place which is EHV premises.

(c) The contractors should be completely responsible for any electrical accident met by the deployed personnels due to their negligence during execution of work as per the prevailing Labour Act, Odisha,.

22. OUTRIGHT REJECTION OF TENDERS:

The tenders shall be liable for outright rejection if the following have not been compiled.

TECHNICAL SPECIFICATION

1. The Scope of work: -

The work covers for PCC and remetalling in 132KV MCL-I & II, TRF-II bay and 132KV Bus- coupler Bay in 132KV S/Y at 132/33 KV Grid S/S, Angul , under EHT (O & M) circle, Chainpal. The details of supply and work to-be executed are given in the price schedule which is to be executed under the instruction and supervision of the site engineer. The Contractor has to supply all the required materials/ T & P and labour for the above mentioned work

2. Manner of execution:-

The work is to be executed by the following standard civil engineering procedure and as per instruction of the site engineer and technical specification of this tender.

3. Tender Schedule:-

Schedule of different items of the works to be executed is given in the price schedule. The bidders are required to quote their unit rates which should be inclusive of supply of required materials at site including cost of materials, royalty and transportation to site and cost of all labour to execute the work. Taxes if any should be indicated separately.

4. All the material, T & P and labour are to be supplied by the contractor. The material to be used for this work shall confirm and as per the satisfaction of the site in-charge.

5. The contractor has to arrange adequate supply of clean water required for the work whenever necessary at his/her own cost.
