All documents submitted along with the tender must be signed and certified by the authorized signatory of the bidder.
3. No telegraphic tenders/forwarding by FAX will be accepted.
4. This office will not be responsible for non-receipt/late receipt of the tender documents due to postal delay.
5. The tenders shall be furnished strictly as per the terms and conditions of the tender specification. Incomplete tenders will be rejected.
6. The Authority may alter the quantum of work at the time of placing orders. Orders may also be split up among more than one tenderer depending upon necessity & urgency in order to get better service.
7. Only those, who have purchased the tender specification from this office by their name/Firm's name can submit their tender. Tenders submitted by others will be rejected.
8. Tenders will be submitted in person/by registered post with A.D. Tenders submitted by any other means shall not be accepted. Postal delay shall not be considered. Tenders received after due date and time shall be returned un-opened.
9. EMD fully exempted as per order of Director(Fin.) OPTCL, BBSR.
10. The authority reserves the right to reject the lowest or any other tender or all tenders without assigning any reason what-so-ever
11. Offers should be neatly typed without any overwriting and corrections. In case of any correction, the same should be authenticated with signature of the authorized person.
12. In the event of discrepancy or arithmetical error in the bid, the decision of the purchaser shall be final and binding on the tenderer.
14. Conditional tender shall not be accepted and no discount other than the quoted price will be allowed as mentioned in the original offer.

SECTION-II

(GENERAL CONDITIONS OF CONTRACT & TECHNICAL SPECIFICATION)

1. **SCOPE OF CONTRACT:** The job covers "Transportation of materials like conductor, insulators, assorted tower members, Nuts & Bolts, Hardware fittings, template & tower accessories etc. from Bharatipur Store(Pipili) to EHT Store at Mancheswar with associated Loading, Un-loading, Sorting & Stacking" and (2) "Transportation of different tower structure materials with Nuts & Bolts, conductor & insulators from Phulnakhara store to EHT Store at Mancheswar with associated Loading, Un-loading, Sorting & Stacking". The scope of the work is variable from time to time within the contract period.
2. **NATURE OF PRICE:** The price is firm inclusive of all taxes and duties for the period of contract. Under no circumstances extra price can be claimed by the agencies during the period of contract. GST will be paid extra as applicable.
3. **PAYING AUTHORITY:** DGM (Elect.), EHT (C) Division, Bhubaneswar.
4. **CONSIGNEE & SUPERVISING OFFICER:** Sub Divisional Officer-(Ele.) , EHT (C) Sub-Division, Pratapsasan.
5. **TERMS OF PAYMENT:** 100% payment shall be released by the paying officer after deduction of statutory taxes and duties upon presentation of bills in triplicate and due certification by the consignee about satisfactory completion of work & furnishing of supporting documents by the Firms.
6. **REGISTRATION CERTIFICATE:** The Transport Agency has to furnish the copy of the valid transport license at least One year experience in goods transportation work, GSTIN, PAN, Contract labour license, EPF and ESI registration along with their tender. All applicable taxes will be deducted as per statutory/ OPTCL's rules.
7. **RESPONSIBILITY OF THE TRANSPORTER :**
 - i. It is the prime responsibility of the Transport agency to ensure that Drivers & Helpers engaged get their wages.
 - ii. Also it is the responsibility of the transport agency for any compensation arising out of accidents and to be disposed of by the transport agencies & having no financial burden on OPTCL.
 - iii. Notwithstanding anything mentioned in the Tender specification or the subsequent approval of acceptance by the owner, the ultimate responsibility for satisfactory performance shall rest with the transporter.
 - iv. The driver should possess the valid Driving license & Regd. card of the vehicle.
 - v. The Permit license of the vehicle carrying the materials should be valid.
 - vi. The Driver should provide his contact no./mob no.
 - vii. The Contractor is fully responsible and liable for any loss or damage of equipment / materials of OPTCL.
8. **RIGHT TO REJECT/ TERMINATE THE CONTRACT :**
 - i. The information furnished by the contractor/ transport agency in their bid if found to be misleading to get the order illegally, the contract will be terminated forth with, along with forfeiture of EMD and the contractor/agency shall be black listed.
 - ii. In case of performance being found to be unsatisfactory continuously for two months and the Transport agency does not respond to the complaint of OPTCL authorities from Division, the contract for the entire work shall be terminated on serving one month's notice from OPTCL's side.
9. **CONTRACTOR'S DEFAULT LIABILITY:** The Owner may, upon written notice of default to the Transport agency, terminate the contract in circumstances detailed hereunder.

If in the judgment of the owner, the firm fails to execute the entrusted work satisfactorily within the time specified in the contract or within the period for which extension has been granted by the owner in writing in response to written request of the contractor.

If in the judgment of the owner the contractor/ Agency fails to comply with the provisions of this contract.
10. **FORCE MEASURE :** The contractor/ Agency shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force measure such as acts of Gods, acts of public enemy, acts of Govt., Fires, Epidemics, Quarantine

restrictions, strikes, Freight Embargo, provided that the Transport agency shall within 3 days from the beginning of such delay notify the owner in writing for cause of delay, upon which the owner shall verify the facts and grant such extension as facts justify.

11. **AGREEMENT:** The contractor shall have to execute an agreement with the concerned paying officer for which he has been allotted the works. The concerned Consignee shall be responsible for supervision of works.
12. **PENALTY FOR DELAY IN COMPLETION OF CONTRACT:** If the contractor/ Agency fails to provide service as per the contract, an amount 5% of the contract value will be deducted from the bill.
13. **RECOVERY FROM THE CONTRACTOR:** The Contractor is fully responsible and liable for any loss or damage of equipment / materials of OPTCL. Full cost of damages caused to equipment/materials of OPTCL during Transportation will be recovered from the bills/ or by encashment of EMD.
14. **JURISDICTION OF COURT:** It is hereby agreed that suits arising out of this contract, if any, by either party, shall be filed in a court of law to which the jurisdiction of High Court of Odisha extends.

If awarded the contractor has to acknowledge acceptance of the work order within 07 (seven) days from the date of issue as a token of acceptance and consent to carry out the work as per the terms and conditions laid as in work order/ tender specification with a understanding of the literally meaning of all the terms of conditions in the LOI & Tender specification and submit the required Bank Guarantee within 07 days (seven) from the date of issue of this work order.

15. **OUTRIGHT REJECTION OF TENDERS:** - The tenders shall be liable for outright rejection if the following have not been complied.
 - a. Tenderers should have purchased the tender specification from this office in his own or firm's name.
 - b. Tenders shall be submitted in person or by Registered post with A.D. and received before the time fixed for receipt of tender.
