



# **SECTION-II**

# **GENERAL TERMS AND CONDITIONS OF CONTRACT** [G.T.C.C]

#### 1. <u>Scope of the contract:</u>

The scope covers repair and reconditioning of defunct high velocity water spray fire fighting system at 400/220/132/33KV Grid Sub-station, Mendhasal on turnkey basis with supply of materials, tools and plants, transportation and other ancillary equipments as required for successful completion of the work. If deemed necessary, a site visit shall be undertaken by the interested bidder before quoting for assessment of the extent of work involved.

All other materials which have not been mentioned or included in schedule of quantity and are required at site for proper execution of the work shall also be supplied by the contractor.

#### 2. **Qualifying Requirements**

- a) The bidding firm should have similar type of work experience with minimum order value of twenty (20) lakhs and taken up the work to the satisfaction of the customer.
- b) The bidding firm / establishment should have ISO certification, GST Registration certificate, ESI & EPF registration & permanent account number [PAN] of the firm.
- c) Qualification of bidder will be evaluated on meeting the minimum pass / fail criteria specified below regarding based on the Bidder's technical experience and financial position. The bidder shall also be required to furnish the requisite supporting documents in support of Qualifying Requirements. **The bid can be submitted by individual firm only.** OPTCL, being the owner may assess the capacity and capability of the bidder, to ascertain that the bidder can successfully execute the work with strict adherence to the scope within stipulated completion period. Notwithstanding anything stated herein, the owner/OPTCL reserves the right to assess the capacity and capability of bidder if circumstances warrant such assessment in overall interest of OPTCL.
- 3. <u>Manner of execution</u>: The whole work shall be done as per the instruction of the engineer in- charge and as per the guide lines of NFPA 15 and TAC.
- 4. <u>**PERIOD OF EXECUTION:-**</u> The work shall be carried out and completed in all respect within 60 days (two months) from the date of issue of this work order.
- 5. <u>INSPECTION:</u>- Consignee/ Supervising officer may inspect the work during the period of execution.

#### 6. Language and measures:

All documents pertaining to the contract including specifications, schedule, notices, correspondence, operating and maintenance instructions or any other writing shall be written

in English language. The metric system of measurement shall be used exclusively in this contract.

#### 7. <u>Right to reject/accept any tender</u>:

The Purchaser reserves the right either to accept or reject any or all tenders if the situation so warrants in the interest of OPTCL. Orders may also be split up between different Tenderers on individual merits of the Tenderer. The Purchaser has exclusive right to alter the quantity of work at the time of placing final work order.

8. <u>COMPENSATION</u>:- The contractor shall be fully responsible for paying compensation, if any under the Labour. Act on account of workmen deployed by him. He must have followed all the safety rules, procedures and provide all the required protective equipments to his workmen as they are to work in surroundings of Extra High Voltage System. OPTCL in no way will be responsible for payment of any compensation. The contractor is fully responsible for any loss or damage of OPTCL property caused during the course of execution of the work and the cost of such damage shall be borne by the contractor.

#### 9. Force Majeure:

The Contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force majeure such as acts of god, acts of the public enemy, acts of Govt., Fires, floods, epidemics, Quarantine restrictions, strikes, Freight Embargo and provided that the Contractor shall within Ten (10) days from the beginning of delay on such account notify the purchaser in writing for the cause of delay. The purchaser shall verify the facts and grant such extension, if facts justify.

#### 10. Extension of time:-

If the Completion of work is delayed due to reasons beyond the control of the Contractor, the Contractor shall without delay give notice to the purchaser in writing of his claim for an extension of time. The Purchaser on receipt of such notice may or may not agree to extend the contract period as may be reasonable but without prejudice to other terms and conditions of the contract.

#### 11. Guarantee period:

The repair work should be guaranteed for satisfactory operation and against defects in design, materials and workmanship for a period of at least 12(twelve) months from the date of recommissioning of the High Velocity Water System. The above guarantee certificate shall be furnished in triplicate to the purchaser for approval. Any defect noticed during this period should be rectified/replaced by the supplier free of cost to the purchaser provided such defects are due to faulty design, bad workmanship or bad materials used, within one month upon written notice from the purchaser failing which provision of clause 16 shall apply.

#### 12. GST REGISTRATION, PAN CARD, ISO CERTIFICATE:

Clear attested Xerox copies of PAN No./ Valid GST registration & clearance certificate valid on the date of opening of tender should be submitted along with tender, without which tender will be rejected. The Contractor may be requested to produce original PAN card, GST registration and clearance certificate as applicable and all other relevant documents for verification. Those who fail to produce the same and found not to be valid on the date of opening of tender, their tenders will be rejected.

**13. <u><b>OUANTITY VARIATION:**</u> The quantity to be ordered may undergo revision at the time of the placement of the order.

# 14. <u>SECURITY DEPOSIT TOWARDS 100% PAYMENT AND PERFORMANCE</u> <u>GUARANTEE:</u>

The successful tenderer will be required to deposit a sum amounting to 10% of value of the contract in shape of Bank Draft /Bank Guarantee from any nationalized Bank valid for up to two months after the guarantee period, drawn in favour of the paying officers, within 15 days of receipt of the work order. In the event of any breach or default in all or any conditions of the work order, the G.M., EHT (O&M) Circle, Bhubaneswar may forfeit the whole amount of Security deposit. No interest will be paid on the security deposit so deposited by the contractor and will be released after expiry of the guarantee period by the paying officer. The security value must be deposited prior to execution of work.

#### 15. Terms of Payment.

100% of the Contract Value shall be paid after successful completion of the work subject to proper functioning of the fire fighting system. Deduction of Income Tax & other statutory dues shall be as per the prevailing norms of OPTCL.

#### 16. Penalty for Delay in Completion of Contract

Penalty shall be imposed @ 0.5% (half percent) of contract price for each calendar week of delay or part thereof subject to maximum of @ 5% (five percent) of contract amount. Charges towards penalty shall be counted after scheduled date of completion / issue of clear instruction to the contractor for commencement of works by the authority.

## 17. Jurisdiction of the High Court of ODISHA.

Suits, if any, arising out of this contract shall be filed by either Party in a court of Law to which the jurisdiction of High court of ODISHA extends.

#### 18. Correspondences.

#### 19. Outright Rejection of Tenders
