(O&M) Division, Jharsuguda invites sealed Tenders in duplicate from Authorized Dealers and registered ordered suppliers having valid PAN with GSTIN Certificate for procurement of different fire extinguishers (15Nos. of ABC Dry Powder (6 Kg) type, 60Nos. of ABC Dry Powder (9 Kg) type, 15Nos. of CO² (4.5Kg) type and 180Nos. of Fire Ball) for Grid Sub-Station, Budhipadar under EHT (O&M) Division, Jharsuguda.

The tender specification can be obtained from the office of The Dy. General Manager (El.), EHT (O&M) Division, Jharsuguda on payment of Rs. 2000/- (two Thousand only) + GST @ 18% (Non Refundable) in shape of Cash/Bank Draft in favor of EHT (O&M) DIVISION, JHARSUGUDA payable at Jharsuguda on any working day from **Dt. 20.10.2023 to Dt. 03.11.2023** during office hour. In case the B.D made any other nationalized bank payable at any clearing branch at Jharsuguda will be allowed, but the bidders have to deposit the collection fee (Bank transaction fee) along with the paper cost. If any of the above date happens to be a holiday, the next working day will be the corresponding effective date. One Tender paper shall be issued to one Bidder. E.M.D @ 1% of the quoted value should be deposited in shape of Demand Draft / Cash in favour of E.H.T. (O&M) Division, Jharsuguda & payable at Jharsuguda along with Self Attested Copy of PAN and GSTIN Certificate failing which the tender will be liable for rejection.

Bidder should not write their name or any other information on the body of the sealed envelope. Super scribing any other information on the body of the envelop.
