Bidders desirous to hire machineries or equipment's from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.

4. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.

5. Bids shall be received only "online" on or before 17.00 Hours of 05.01.2024.

6. The Bids received "on line" shall be opened at **11.00 Hours on dtd.06.01.2024** in the office of the Superintending Engineer (Civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on at the date of opening of Bids as specified, the bids will be opened on the next working day.

- The bidders shall furnish the self-attested copies of Contract License, PAN, GSTIN and other documents as mentioned in DTCN. They may go through the outright rejection criteria as mentioned in DTCN.
- 8. The successful bidder has to submit a composite Bank Guarantee for Rs.2.0Lakh (Rupees two lakhs only) in favour of Executive Engineer (Civil),CWD1, OPTCL, Bhubaneswar & valid for a period of last date of AMC work order plus 90 days. The same should be strictly as per the Performa enclosed herewith.
- 9. Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference and for availing the facilities. The Security Deposit(Earnest Money, Initial Security and Performance Security) at half the usual rate may be deposited/ realised by/ from the Scheduled Caste or Scheduled Tribe Contractors coming under the categories upto "B" Class only as against the prescribed percentage.
- 10. The packet super scribing the name of the work and containing cost of bid document in original and other documents may be submitted to the office of the undersigned physically or by post(speed post/registered post only) on or before 17.30 Hours on dated 05.01.2024. The

undersigned shall not be responsible for only postal delay. The tenders shall be opened on dated at 11:00 Hrs of 06.01.2024.

- 11. The cost of bid documents in shape of demand draft drawn in favour of Superintending
  Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank mentioned at column 5 above, payable at Bhubaneswar separately towards cost of each tender.
- 12. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine.
- 13. Before tendering, the bidder may visit the sites and satisfy himself, as no claim what-so-ever shall be entertained for any alleged ignorance, after the tender is opened.
- 14. The authority reserves right to cancel any or all bids without assigning any reason thereof.
- 15. The rate of material is inclusive of 1% cess which will be adjusted during payment of bills .The contractor shall have to produce labour licence within seven days of agreement if required by the undersigned.
- 16. EPF and ESI certificate with last 03 month (i.e, September 2023 to November 2023) updated challan is mandatory for qualification.
