The bid should be submitted only online in the http://tenderorissa.gov.in by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).

Bidders desirous to hire machineries or equipment's from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.

- 5. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.

- 12. Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference for availing the facilities. Engineering contractors should submit an attested copy of Engineering degree/diploma certificate and an undertaking in shape an affidavit that he has not availed concession 3 (three) time in the current financial year and the PH bidders Should produce their original registration certificate stating the fact of physically handicapped by their registration authority with the bid, failing which they will not get price preference as per rule.
- 13. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.
- 14. The packet super scribing the name of the work and containing cost of bid document & EMD/Bid Security in original and other documents may be submitted in the office of the undersigned after bid closing date 20.06.2018 and on or before 17.00 Hours on dated 23.06.2018 during office hours on working days .Submission of the same by courier/postal will not be considered.
