ADVERTISEMENT FOR POST OF MANAGING DIRECTOR

About the Company: Neelachal Power Transmission Company Private Ltd (NPTCL), a Joint Venture Company between Odisha Power Transmission Corporation Ltd. (OPTCL) and Mahanadi Coal Fields Ltd. (MCL) is incorporated in 2013 under the Companies Act 1956 for development of Intra-State Transmission Projects in the State of Odisha on Built, Own, and Operate and Maintain (BOOM) basis. The Company invites application from eligible/qualified candidates for the post of **Managing Director** for its office at Bhubaneswar.

Role: The Managing Director is the Chief Executive of the Corporation and accountable to its Board of Directors, and Government. He shall be responsible for the professional and efficient functioning of the Corporation by providing strategic and visionary leadership for achieving its corporate objectives and business growth.

Essential Qualification & Experience: The candidate shall be a Graduate Electrical Engineer with a proven performance track record of minimum 20 (twenty) years of service in Government / Central PSU / State PSU or reputed private sector companies preferably in power sector. He should possess adequate experience in senior level of management in power sector in an organization of repute. The incumbent should be drawing the scale of pay in the pay band of Rs.37400-67000/- with Grade Pay Rs.8700/- or higher (CDA) or Rs 43,200-60,000 or higher IDA). Persons with MBA from a reputed Institute will have added advantage. The turnover of the company in which the applicant is / was working should not be less than Rs.100 crore only.

Scale of Pay: Rs.37400-67000/- + Grade Pay Rs.10, 000/-(CDA) or Rs 65,000-75,000 (IDA). The post carries CDA, HRA, Medical Allowance and perksetcas per Rules. The pay protection will be allowed to the officers from the Central or State Governments / CPSUs / State PSUs or any other Government organization.

Age Limit(on the date of notification): Minimum 45 years and Maximum 57 years.

Tenure of Appointment: The appointment is on tenure basis with initial contract period of three years, which may be extended for a further period based on performance and as per requirements of the company. However, the contract period shall be limited up to age of 60 years.
