CONTRACTUAL ENGAGEMENT OF RETIRED ENGINEER AS TECHNICAL CONSULTANT Advt. No. 6 (1) /Date 28.12.2013

Odisha Power Transmission Corporation Limited (OPTCL), a state owned power utility organisation in Orissa engaged in the business of Transmission of electricity with a vision to emerge as one of the leading utilities in the country in Transmission space, invites applications from retired engineers for engagement as Technical Consultant on contractual basis for a temporary period of one year to supervise the works related to EHT(Construction) and EHT(Operation & Maintenance) of OPTCL.

1. Posts

One Retired Electrical Engineer not below the rank of General Manager will be engaged to supervise the upcoming EHT project construction and substation up-gradation works at various field units of OPTCL.

2. Eligibility Conditions:

- (a) Retired Electrical Engineer not above the age of 63 years having good service records and who are physically fit will be eligible to apply.
- (b) They should possess EHV License issued by ELBO.
- (b) The applicants should have adequate experience and successful track records in project construction. They should have worked as General Managers for a minimum period of three years.
- (c) Officers against whom departmental proceedings or criminal cases are contemplated or pending or who have been penalized for misconduct during the period up to five years preceding their retirement will not be considered for engagement.

3. Selection Process:

Selection will be made through personal interview by a Selection Committee.

4. Tenure, Terms & Conditions:

(a) The engagement will be made for a period of one year, which may be extended further depending on satisfactory performance and requirement of OPTCL.

- (b) The Retired Engineer will be engaged as Technical Consultant on contractual basis on fixed remuneration of Rs.30,000/- per month.
- (c) The Retired Engineer shall not be eligible to get Dearness Allowance or any other Special Pay or Allowance, over & above the consolidated remuneration.
- (d) During the period of contractual engagement, the Retired Officer shall be entitled to get Traveling Allowance for approved tours in line with the Corporation's prevailing norms.
- (e) He will be entitled for mobile reimbursement of Rs 1000/- p.m.
- (f) The engagement will be terminated at any time by OPTCL for dis-satisfactory performance, on notice of one month, and in cases of any misconduct including but not limited to misappropriation, negligence or causing loss to OPTCL without any prior notice.

5. Procedure to Apply

The interested candidates may apply in the prescribed format to the undersigned along with the following documents: (i) Proof of Experience (ii) Copy of EHV License from ELBO (iii) 2 nos. of recent passport size photographs.
