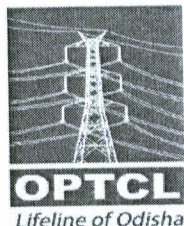

SECTION-IV

TECHNICAL SPECIFICATION

- (1) Each bag containing 50 Kg of good quality Sodium Bentonite Compound in Powder form required to lower soil Resistivity of Grid Sub-Station & complies with IEC62561-7 & must be marked with the manufacture's name, Trade mark or Identifying symbol. In addition to standards, requires a serial or Lot No. on each bag.
- (2) **Sample Testing:- You have to submit the Sample (Minimum 2 Kg) for the aforesaid item at the time of Opening at the office of the undersigned which will be tested before placement of Purchase Order. Otherwise the tender is liable for rejection.**
- (3) The material must absorb & retain water at a higher rate & the material being used to lower the resistivity must not be corrosive to the galvanized earth electrode.
- (4) The report of the following tests & any other extra test on the structure & content of the product as per IEC62556 may be submitted by the bidders.
 - i) Leaching Tests
 - ii) Sulphur Test
 - iii) Determination of Resistivity
 - iv) Corrosion Test

The report should include a title or subject of the report, a test identification no., contact information of the testing Laboratory, contact information of the manufacturer & a report issue date. The report must include the signature & title of the person authorized to sign for the laboratory & the person who conducted the test.
