

### **INSTRUCTIONS TO TENDERER**

#### **1. Submission of Bids: -**



## Section-II

### General Terms and Conditions of Contract

**1. SCOPE OF CONTRACT:**

The scope of the contract covers the **Tightening Of Jumpers alongwith replacement of damaged clamps in 220KV lines under EHT (O&M) division, RAYAGADA**

The details of scope are enumerated in SECTION-III, Annexure-III.

**2. PRICE:**

The bidders are advised to quote their rates as per the attached price schedule. The price should be firm. The tenderer should fill up the price schedule properly and in full. The tender may be rejected if the schedule of price is submitted in incomplete form.

**3. COMPLETION PERIOD:**

The work shall be completed within **45 days** from the date of issue of work order. The authority however reserves the right to schedule/reschedule the work progress timeline.

**4. EXTENSION OF TIME:**

If the work completion is delayed due to any reason beyond the control of the contractor, then the contractor shall without delay give notice to OPTCL in writing for an extension of time with detail justification. The Authority on receipt of such notice may agree to extend the contract delivery date if reasonable but without prejudice to other terms and conditions of this contract.

**5. VALIDITY:**

The price with terms and conditions of the offer shall be valid for a minimum period of **180 days** from the date of opening of tender failing which their tenders will be rejected.

**6. TERMS OF PAYMENT:**

100% payment with taxes and duties will be paid after completion of the work in all respect which shall be certified by the executing officer subject to approval of guarantee certificate and availability of funds.

**8. PRICE REDUCTION FOR DELAY IN WORK COMPLETION:**

- i). If the contractor fails to deliver the materials/execute the work within the delivery/stipulated period as stipulated under Clause No.3 (Section-II) of this tender document or any extension granted thereto, the purchaser shall recover from the supplier price reduction for a sum of half percent (i.e. 0.5 percent) of the contract price for each calendar week or part thereof of limited to maximum of 5% of cost (exclusive of GST) of the undelivered portion of the materials/equipment's and incomplete portion of the work.
- ii). The total amount of price reduction schedule for delay under the contract will subject to a maximum of 5% (five percent) of the contract value (exclusive of GST) to be applicable after the completion of supply and erection before release of Security Deposit-cum-Performance Guarantee.
- iii). OPTCL shall recover the price reduction schedule from the bill of the Contractor.
- iv). However, if the price reduction schedule remains un-recovered the same shall be recovered from the contract performance Bank Guarantee.

**9. GUARANTEE PERIOD:**

The work executed shall be guaranteed for a period of **12 (twelve)** months from the date of completion & certification by the Engineer-in-Charge. The guarantee certificate shall be furnished in triplicate to the office of the undersigned for approval before release of payment. Any defect if noticed



during this period shall be rectified free of cost provided such defects are due to bad workmanship, bad materials used upon written notice from the authority concerned.

**10. GST REGISTRATION CERTIFICATE, PAN CARD, CONTRACTOR LICENSE & EXPERIENCE CERTIFICATE:**

Self-attested legible photocopies of Income Tax PAN Card, GST Registration Certificates and EHT/ H.T. contractor license issued by Chief Electrical Inspector, Odisha & relevant experience certificates towards similar nature of works in the field of power sector, if any, valid on the date of opening of the tender should be submitted along with tenders without which tender will be rejected at the time of opening. If required, the firm may be asked to produce original documents for verification any time after opening of the tender. Those who fail to produce the same and found not to be valid on the date of opening of the tender, their tenders will be rejected. **All documents of the tender should be signed by the authorized signatory.**

**11. COMPENSATION:**

The agency shall be fully responsible for payment of compensation, arising whatsoever in the case of any accident/ injury to the workmen deployed by the agency under the Workmen Compensation Act. OPTCL in no way will be responsible for payment of any compensation. Agency shall pay all claims/ compensation/ damages/ penalty/ fine or any amount payable to the individual/ authorities payable due to accident/ injury to the person deployed by the agency.

**12. SAFETY & SECURITY:**

Adherence to statutory Safety practices at work site as per CEA regulations, 2011 (Safety requirements for construction, operation and Maintenance of Electrical plants and Electric lines). The contractor will supply all the ISI marked personal protective equipment (PPE) like Helmet, Safety Shoe, Hand Gloves, and Safety Belt etc. at their own cost to the deployed persons that shall work in Extra High Voltage System while adhering to mandatory work site safety practices. The safety of contract personnel (Skilled, Semi-skilled or Unskilled) deployed by the contractor shall be sole responsibility of the contractor.

**13. SUBMISSION OF PROOF REGARDING PAST EXPERIENCE: -**

The bidder is required to submit the list of similar nature works executed by him in support of his past experience along with the tender. Documents such as Completion Certificate, Work orders, Experience certificates are to be enclosed along with the tender documents.

**14. SECURITY- DEPOSIT:**

## ANNEXTURE-IV

### STRATEGY FOR E-REVERSE AUCTION

1. e-Reverse Auction (RA) will be conducted by KEONICS on specified date and time, while bidders shall quote from their own offices/places of their choice. Internet connectivity shall be ensured by the respective agencies/bidders themselves.
2. KEONICS shall arrange to demonstrate/train (if not trained earlier) the bidder's nominated person(s), without any cost. They will also explain all the rules related to e-Reverse Auction / Business Rule document to be adopted.
3. The strategy to be used for reverse auction shall be "DYNAMIC TEMPLATE BIDDING "

#### **Procedure for electronic Reverse Auctioning {e-RA}:**

4.
  - 4.1 The e-RA shall be conducted on [www.tenderwizard.com/OPTCL](http://www.tenderwizard.com/OPTCL) only.
  - 4.2 Bidder must submit letter towards agreement to the Process related Terms & Conditions for e-Reverse Auction, as per (Reverse Auction Process Compliance Form at Annexure-I). In case of non-receipt of the same, vendors will not be allowed to participate in e-RA.
  - 4.3 e-RA shall be carried out after opening of Price bids and completion of Price bid evaluation, which will be intimated only to the techno-commercially qualified bidders by OPTCL as per procedure given below.
  - 4.4 OPTCL reserves the right to conduct e-RA, and it is obligatory on part of bidder(s) invited to participate in e-RA process once they have responded to the techno- commercial bid.
5.
  - 5.1 Prior intimation/ Notice for RA invitation will be given to techno-commercially qualified bidders regarding the date & time of opening of the e-RA.
  - 5.2 The start bid price (SBP) for e-Reverse Auction of each bidder under a particular package shall be the L1 evaluated price for the subject package including Taxes & Duties for the total scope for subject Package. Taking the above discovered L1 price as the upper limit e-RA will be conducted to determine the lowest possible price.
  - 5.3 Reverse Auction will be conducted amongst first 50% of the technically qualified bidders arranged in order of prices from lowest to highest, as L1, L2, L3Ln, and L1 price will be discovered. A minimum of 3 bidders shall be eligible for e RA. (e.g. If 4 bidders are financially evaluated then the L1, L2 and L3 bidders shall be eligible for e-RA). Number of bidders eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L1 to L4).
  - 5.4 However, in case only two bidders are found to be responsive, e-RA would be carried out with both the parties without any elimination. However, OPTCL reserves the right to invite the evaluated L1 bidder for negotiation without conducting the e-RA, in case the price submitted by any bidder is found to be abnormal, OPTCL reserves the right to reject the bid of the bidder(s).
  - 5.5 Rank of bidders would be displayed as per the total cost to OPTCL, i.e. including Taxes and Duties payable by OPTCL as per the provisions of the bidding document & after e-RA process is over.
6.
  - 6.1 Names of bidders/ vendors shall not be disclosed during the e-RA process. Names of bidders/ vendors shall be anonymously masked in the e-RA process, and they will be given suitable alias names.

6.2 In the case of RA, start/ reference price and step value of decrement shall be indicated to the bidders at the start of the auction. Any participating bidder can bid one or multiple step decrements lower than the prevailing lowest bid at that time. The Bidder shall be able to view Bid Start Price, Bid Decrement Value, Prevailing Lowest Bid value, last Bid Placed by him and time left for bidding.

6.3 The step value of decrement in a package to be offered by bidder (the minimum amount of reduction in the total bid price including all taxes & duties during auction), shall be kept at 0.15% of L1 bidder's final evaluated price (or) at approved amount as per recommendation of the competent committee.

6.4 Bidders can only quote any value lower than their previous quoted price. However, at no stage, increase in Price will be permissible.

6.5 At any point during Reverse Auction, bidding Price field shall remain enabled for the bidders. The reverse auction period shall be unlimited and the initial auction period (1st slot) will be of thirty (30) minutes with provision of auto extension by (10) ten minutes from the schedule/ extended closing time. If any fresh lower bid is received in last ten minutes of initial auction period or extended auction period, the auction shall get extended automatically for another 10 minutes. In case, there is no bid received during schedule/extended slot, the auction shall get closed automatically without further extension.

6.6 However, bidders are advised not to wait till the last minute or last few seconds to enter their bid during the period of e-reverse auction to avoid complication related with internet connectivity, network problem, system crash down, power failure etc.

## 7.

7.1 After conclusion of e-Reverse Auction i.e. (Closing Price in Reverse Auction will be taken as offered price by the L1 bidder), decrease in price of individual head of the template shall be considered proportionately on all individual line items of the respective head of the price schedule of the successful L1 bidder.

7.2 Any bid received at the tender wizard server end subsequent to closure of the e-RA shall be summarily rejected and shall not be considered as a valid bid under whatsoever circumstances. For this purpose, the KEONICS / tender wizard server log shall prevail.

7.3 The bidder shall not involve himself or any of his representatives in price manipulation of any kind directly or indirectly by communicating with other bidders.

7.4 During Reverse Auction, if no bid is received within the specified time, OPTCL, at its discretion, may decide to close the reverse auction process/ proceed with conventional mode of tendering [ Evaluation of Part-II (price bid) submitted by bidders earlier].

## 8.

8.1 Consequent upon completion of e-Reverse Auction, OPTCL's decision on award of contract shall be final and binding on the bidders.

8.2 OPTCL shall be at liberty to call the L1 bidder for further process/ negotiation and also at liberty to cancel the e-reverse auction process/ re-tender at any time, without assigning any reason thereof. OPTCL can decide to reschedule or cancel any reverse auction: the bidders shall be informed accordingly.

8.3 OPTCL/ Service Provider shall not have any liability to bidders for any interruption or delay in access to the e-Tender site/ Reverse Auction link irrespective of the cause.
