GENERAL TERMS AND CONDITIONS

<u>INSTRUCTION TO BIDDERS (CHECK LIST)</u>

- 1. The bidders must read in detail the "instruction to the bidder" and general terms and conditions before filling the tender documents.
- **2.** Experience: The bidders should be of registered order Manufacturers/Suppliers. The bidder may submit the copy of past experience if any regarding supply of similar materials to OPTCL / any other Odisha Govt. Organization.

3. TENDERS:

- a. Bidders must submit the tenders in duplicate in the specified specification only.
- b. Tender must be submitted in sealed envelopes super scribed as "Quotation for tender call notice no. EHT(C)/T/04/2019-20 (Supply & Installation of AC Machines and Stabilizer at EHT (Const) Circle, Sambalpur) and addressed to the General Manager, Electrical, EHT (Const) Circle, Sambalpur.
- c. Tender shall be submitted either in person or by registered post with A.D. Any other means of submission shall not be accepted. Detailed postal address with Pin No, Telephone/Mobile No, FAX No, and Email address must be mentioned on the tender bid. Tender received after due date and time due to postal delay or any other reason will not be considered.
- d. Conditional offer will not be considered.

4. EARNEST MONEY DEPOSIT:

- i) The tenderers are required to **deposit EMD** @ 1% of the estimated cost, i.e. Rs. 1487/-, in shape of Bank Draft/ Pay Order only drawn in **favor of "EHT** (Construction) Circle,OPTCL,Sambalpur", payable at Sambalpur. The EMD will be refunded to the unsuccessful bidders on written request after finalization of tender. No cheque shall be accepted. The tender without EMD will be liable for rejection.
- ii) No interest shall be paid on earnest money deposit.
- iii) No adjustment towards EMD shall be permitted against any outstanding amount if any remained with this Office. In case of less deposit of EMD, the tender shall be liable for rejection.
- iv) The EMD of successful bidders can be refunded on written request after completion of the Guarantee period.

- **5. INFORMATION ON COMPETITIORS:** Bidders have right to know information on competitors only at the time of opening of the bids of competitors. SCOPE OF THE WORK & OTHER CONDITIONS OF CONTRACT

1. SCOPE OF CONTRACT:

The scope of contract shall be delivered free on road transport at destination or at our OPTCL site with Installation.

2. PRICE/RATE:

The price quoted should be firm, inclusive of all taxes and duties and GST. F.O.R. Destination. .

3. DESTINATION:

EHT(Const) Circle, Sambalpur.

4. VALIDITY:

The rate with terms and conditions of the offer shall be valid for a minimum period of 180 (one hundred eighty) days from the date of opening of tender.

5. TERMS OF PAYMENT:

100 % (Hundred Percent) payment with taxes etc. shall be made after receipt of materials in full land in good condition and verified thereof by the consignee subject to availability of funds from the Head quarters office.

6. PENALTY:

If the supply with installation is not made within the stipulated period the Penalty shall be imposed @ 0.5 % (Half Percent) per week subject to a maximum of 5% (five percent) of such portion of contract which remain undelivered within the stipulated period. The date of receipt shall be treated as the date of delivery. The imposition of penalty is however subject to force major condition

7. <u>DELIVERY:</u>

The materials in full quantity shall be delivered & installed within 30 days of issue of purchase order failing which purchase order shall be liable for cancellation. However early delivery shall be preferred.

8. GUARANTEE:

The materials covered under this contract should be guaranteed as per the manufacturers Guarantee policy. Any defects noticed during this period should be rectified/replaced by the firm free of cost to OPTCL provided such defects are due to faulty design, bad workmanship or bad material used. The replaced materials also have similar guarantee.

09. AUTHORITY:

10. GST & I.T. PAN:

Clear self attested Xerox copies of valid GST Registration Certificate, IT, PAN, should be submitted along with tenders without which tender will be rejected.
