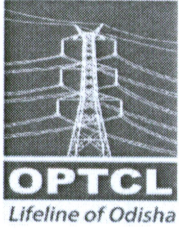

No., PAN for Painting of EHT Towers of 132 KV Budhipadar-Jharsuguda S.C line (19 Nos. of tower) from Loc. No. 01 to 19 under E.H.T. (O&M) Division, Jharsuguda.

The tender specification can be obtained from the office of The GM EHT (O&M) CIRCLE, BURLA on payment of **Rs. 4000/- (Four Thousand only)+GST @ 18% (Non Refundable)** in shape of Cash/Bank Draft in favor of EHT (O&M) CIRCLE, OPTCL, BURLA payable at, BURLA, Sambalpur on any working day upto **05.00PM from Dt.02.08.2025 to Dt.18.08.2025**. In case the B.D made any other nationalized bank payable at any clearing branch at Burla will be allowed, but the bidders have to deposit the collection fee (Bank transaction fee) along with the paper cost. The collection fee & Paper cost is Nonrefundable. Additional amount of Rs.100/- (One Hundred only) may be paid extra for postal delivery of the tender specification. The undersigned shall not be held responsible for any postal delay.

**The Tender shall be received Up to 13:00Hrs of dated 19.08.2025 & will be opened at 15:30 Hours of same day** in the Office of the undersigned in the presence of the Bidders (or) their Authorized Representatives present if any. If any of the above date happens to be a holiday, the next working day will be the corresponding effective date. One Tender paper shall be issued to one Bidder. E.M.D @ 1% of the total quoted value should be deposited in shape of Demand Draft / Cash in favour of E.H.T. (O&M) Circle, Burla & payable at "Union Bank of India", Burla Branch along with Self Attested Copy of PAN and GST Registration Certificate failing which the tender will be liable for rejection.

### SECTION-III

#### 1. Scope of the contract:

- a) All the surfaces to be painted shall be free from grease, oil and other contaminants by applying de-greasing solvent.
- b) Removal of rusting is to be done and surfaces to be cleaned by making full use of mechanical tools along with manual scrubbing and wire brushing.
- c) Surface to be washed thoroughly and then dried properly.
- d) Painting over tower structure by applying one coat of zinc phosphate primer of ASIAN/ BERGER make.
- e) 2 coats of Aluminium paint of ASIAN/ BERGER make and applying one coat of black enamel paint over tower leg up to a height of 1Mtr.

The painting work shall be done carefully in such a way that the paint shall not scale off or crinkle or shall not be removed by abrasion due to normal handling and capable to withstand extremely of weather condition.

All materials required for painting including Berger paints, Asian Paints, thinners etc., tools and plants are to be supplied/ arranged by the contractor. A joint verification report made by contractor with the consignee regarding use of genuine quality of primer & Berger/ Asian make paints to be used for painting works towers with the bill.
