The bidders who want to submit bids shall have to pay non-refundable amount Rs.14,160/-(Fourteen Thousand One Hundred Sixty)only including GST @ 18%) towards the tender cost, online through e-payment gateway link provided in e-tender portal (by using Net Banking, Debit Card or Credit Card).
