- 1. For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites **item rate bids** in **Single Cover system** for the works through e-procurement as detailed in the table. The bid should be submitted only online in the http://tenderorissa.gov.in by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).
- 2. The bidders may submit bid for the work as per the following table :-

- 3. Bid documents consisting of specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website http://tenderodisha.gov.in as specified at column-8 above except on Sundays and public holidays.
 - (i) Bids must be accompanied by and Earnest Money Deposit / Bid Security of the amount @ of 1 % of the estimated cost specified for the work in shape of Deposit Receipt of Schedule Bank /N.S.C. / K.V.P. / Post Office Savings Bank Account /Post Office Time Deposit Account pledged in favour of EE, CWD-I, OPTCL BBSR and will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire machineries or equipment's from outside the State orowned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.
- 4. The Bid documents will be available in the http://tendersorissa.gov.in from 12.00 Hours of 12.03.2021 to 22.03.2021 up to 17.00 Hours.
- 5. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-III or Class-III.
- 6. Bids shall be received only "online" on or before 17.00 Hours of 23.03.2021
- 7. The Bids received "on line" shall be opened at **11.00 Hours on dtd.24.03.2021** in the office of the Superintending Engineer (civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day.
- 8. The bidders shall furnish the self-attested copies of Contract License, PAN, GSTIN and other documents as mentioned in clause no 26 of the DTCN. They may go through the outright rejection criteria as mentioned in DTCN.
- 9. Additional performance security shall be obtained from the bidder before drawl of agreement. He has to submit when the bid amount is less than the estimate cost put to tender. In such an even the bidder who have quoted less bid price/rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost i.e. estimate cost put to tender minus the quoted amount as Additional Performance Security in Shape of DemandDraft/NSC/KVP/Term Deposit Receipt pledge in favour of EE, CWD-I, OPTCL, BBSR at the time of agreement.
- 10. Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference for availing the facilities. Engineering contractors should submit an attested copy of Engineering degree/diploma certificate and an undertaking in shape an affidavit that he has not availed concession 3 (three) time in the current financial year andthe PH bidders Should

produce their original registration certificate stating the fact of physically handicapped by their registration authority with the bid, failing which they will not get price preference as per rule.

- 11. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.
- 12. The packet super scribing the name of the work and containing cost of bid document & EMD/Bid Security in original and other documents may be submitted in the office of the undersigned after bid closing date 22.03.2021 (after 5 pm) and on or before 17.00 Hours on dated 23.03.2021 during office hours on working days .Submission of the same by courier/postal will not be considered.
- 13. The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank mentioned at column-7 above, payable at Bhubaneswar **separately** towards cost of each tender.
- 14. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine.
- 15. Before tendering, the bidder may visit the sites and satisfy himself, as no claim what-so-ever shall be entertained for any alleged ignorance, after the tender is opened.
- 16. Corrigendum/Addendum if any will be uploaded in the e procurement portal http://www.optcl.co.in& in OPTCL website.
- 17. Other details can be seen in the bidding documents.
- 18. The authority reserves right to cancel any or all bids without assigning any reason thereof.
- 19. The amount put to tender is inclusive of 1% cess which will be adjusted during payment of bills .The contractor shall have to produce labour licence within seven days of agreement if required by the undersigned
- 20. The unsuccessful contractors shall have to claim for refund of EMD within a period of one year from the date of drawl of agreement and shall have to claim for Security deposits within a period of three years from the date of completion of contract, Otherwise it will be forfeited.
- 21. If any bonafide mistake or omission in the wording, description of item, unit, quantity and any clause in TCN / Tender schedule / Tender paper document is left unnoticed & inadvertently & the same is detected

after sale of the bid document, then the Tender inviting authority i.e. the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar reserves every right to correct that and all purchasers will abide by that correction.
