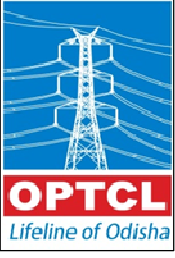

Sealed tenders are invited from the eligible bidders for hiring of diesel run commercial registered light vehicle **AC -Bolero or equivalent (7 seater)** on monthly contract basis for a period of **One year** for **EHT (O&M) Division, Cuttack**. Normally the vehicle will be stationed at office of the **DGM, EHT (O&M) Division, Cuttack**.

The vehicle to be provided should not be more than 2 (two) years old as on the date of opening of tender. Fuel reimbursement – Diesel @ 10 KM/ Ltr for Bolero or equivalent and Lubricant @ 750 KM/ Ltr.
