For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites percentage rate bids in **Double Cover system** for the works through e-procurement as detailed in the table. The bid should be submitted only online in the <http://tendersodisha.gov.in> by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).

2. The bidders may submit bid for the works as per the following table :-

4. **Bids must be accompanied by and Earnest Money Deposit / Bid Security of the amount @ of 1 % of the estimated cost put to tender** specified for the work in shape of Deposit Receipt of Schedule Bank /N.S.C. / K.V.P. / Post Office Savings Bank Account /Post Office Time Deposit Account **pledged in favour of SE, CWC, OPTCL BBSR** and will have to be in any one of the forms as specified in the bidding document.
5. The Bid documents will be available in the <http://tendersodisha.gov.in> from **11.00 Hours of 22.04.2026 to 12.05.2026 up to 17.00 Hours.**
6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
7. Bids shall be received only **“online”** on or before **17.00 Hours of 12.05.2026.**
8. The Cover-I ( Techno-Commercial Document) of the Bids received **“on line”** shall be opened at **11.00 Hours on 14.05.2026** in the office of the Superintending Engineer (civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day. The date of opening of CoverII(BOQ) will be communicated in due course of time to the qualified bidders of Cover-I.
9. The bidders shall furnish the attested copies of the valid Contract Licence, Pan, GST, list of works in hand along with self-attested copies of supporting documents and Schedule-A to F & other documents as mentioned in DTCN.
10. **Additional performance security** shall be obtained from the bidder **before drawl of agreement**, he has to submit the Additional Performance Security for the amount as detailed below in Shape of Bank Guarantee/ NSC/KVP/Term Deposit Receipt pledge in favour of **SE,CWC,OPTCL, BBSR at the time of agreement.**

The extant provisions of threshold negative bid caps (14.99%) Introduced in Appendix-IX, Clause 36 of OPWD Code Volume-II has been abolished in the procurement of works undertaken by the Govt of Odisha and its agencies to ensure the procurement process results in a viable and successful manner with adoption of following incremental Additional Performance Security (APS) system.

Additional performance security shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as under:

  - I . where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/security percentage is required.
  - II . where the bid price is below 10% but not below 20% of the project cost put to bid. the additional performance guarantee/security percentage shall be intrermented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price;
  - III . where the bid price is 20% or more below of the project cost put to bid, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bld price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price;

IV . The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.


V . The additional performance security shall be treated as part of the performance security

VI . Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security(APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document., If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/ Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.

11. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.
12. **The packet super scribing the name of the work and containing cost of bid document & Affidavit in original and other documents may be submitted in the office of the undersigned on or before 17.00 Hours on dated 13.05.2026** during office hours on working days failing which the bid will be rejected
13. The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank, payable at Bhubaneswar **separately** towards cost of each tender. The purchaser of the demand draft has to be the bidder himself or his authorised representative. In case of authorised representative, the bid must be accompanied by a affidavit/undertaking of authorisation.
14. E-Reverse Auction (if applicable) shall be held on [www.tenderwizard.com/OPTCL](http://www.tenderwizard.com/OPTCL) amongst the technically qualified bidders who will be invited as per the terms laid in DTCN.
15. **The bidders should have successfully executed/completed at least a single similar nature of work, worth 80% of tender value or two numbers of similar nature of work, worth 50% of tender value of each work during the last five financial years 2020-2025.** The bidders failing to produce authenticated document in support of work experience from competent authority is liable for rejection. Experience certificate from any Private Organisation will not be entertained. Experience certificate furnished below the rank of Executive Engineer of Government Department/ Public Sector Undertaking will not be accepted. The original agreement in support of experience certificate submitted by the bidder

will be verified before opening of the financial bid.

16. **EPF and ESI certificate with last 03 month (January 2026 to March 2026)** updated challan is mandatory for qualification.
17. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine.

19. Other details can be seen in the bidding documents.
20. The authority reserves right to cancel any or all bids without assigning any reason thereof.
